**NOTIFICATION**

It has been observed that there is a tendency of change of use of land pertaining to Petrol Pumps into other uses. There is also a need of commercial use within industrial buildings for the purpose of promotion of various industrial activities. Therefore it has been felt to amend the Land Use and Development Control Plan (LUDCP) for Ward 45 of the Calcutta (Kolkata) Municipal Corporation Area published and notified in the Official Gazette dated 05/08/1997 under Notification No. 535/CMDA/Seect/VIII-22/85(Pt-I) dated 31/07/1997 under section 40 of the West Bengal Town and Country (Planning and Development) Act, 1979 to incorporate provisions with regard to:

- 1. Restriction of any Change of Land Use of the Petrol Pumps or any Vehicle Refuelling Stations.**
- 2. Allowing mixing of Commercial Uses (Mercantile Wholesale and Retail both) up to a maximum of 20% of the total Built-up Area in the Industrial Buildings listed under Green, White and Exempted Categories of Industries as mentioned in the Order of West Bengal Pollution Control Board, Department of Environment, Govt. of West Bengal [Memo No. 1512/4A-18/2010 (Pt.I) dated 14.06.2016] subject to consideration of the Industrial Siting / Locational Policy in West Bengal, existing ground situation and other Planning Guidelines/Norms.**

The proposed amendments of the said document have been duly directed to be processed as per provisions under section 40 of the West Bengal Town and Country (Planning and Development) Act, 1979 by Urban Development and Municipal Affairs Department, Government of West Bengal. As per sub-section (1) of section 36 of the West Bengal Town and Country (Planning and Development) Act, 1979, the proposed amendment is hereby notified in the 'Official Gazette'. ## **Draft Amendment**

of the

**"Land Use and Development Control Plan for Ward 45 of the Kolkata Municipal Corporation Area Being a Portion of the Kolkata Metropolitan Planning Area" u/s 40 of the West Bengal Town and Country (Planning and Development) Act, 1979**

### **In Chapter 9**

The Clause 9.3 which has been written as "For the plots and premises mentioned in Schedule VI of this Land Use and Development Control Plan change of the present occupancy or occupancies is prohibited" shall be substituted and may be read as:

*"For the plots and premises mentioned in Schedule VI and Schedule VI-A of this Land Use and Development Control Plan change of the present occupancy or occupancies is prohibited"*

The Clause 9.4 which has been written as "The said Schedule-IV, Schedule-V, or Schedule-VI may, with the previous approval of the State Government and by notification in the official gazette, be modified as may be felt necessary in the public interest, during the process of implementation of this Land Use Development Control Plan" shall be substituted and may be read as:

*"The said Schedule-IV, Schedule-V, Schedule-VI, or Schedule VI-A may, with the previous approval of the State Government and by notification in the official gazette, be modified as may be felt necessary in the public interest, during the process of implementation of this Land Use Development Control Plan"*

### **In Chapter 10**

After the existing provisions in Chapter 10, the following shall be inserted,

*"10.1 Notwithstanding anything contained hereinabove, mixing of Commercial Uses (Mercantile Wholesale and Retail both) may be allowed up to a maximum of 20% of the built-up area, in the Industrial buildings, listed under Green, White and Exempted Categories of Industries as mentioned in the Order of West Bengal Pollution Control Board, Department of Environment, GoWB [Memo No.: 1512/4A-18/2010 (Pt.I) dated 14.06.2016] subject to the consideration of the Industrial Siting / Locational Policy in West Bengal, existing ground situation and other Planning Guidelines/Norms."*
