- 6 Submission of Quotation : Rates are to be quoted by the bidders in their own company letter head as per format given in the notice. The quoted amount ( both in figures and words) should include GST and L.W. Cess.

- 8 Date & time limit for submission of quotation : From 02.07.2026 ,14.00 hours to 10.07.2024, 14.30 hours.

## 2. Scope of Work:-

Spraying of insecticides, the preventive measure for reducing mosquito borne diseases, in the HIT Building and compound premises at 19, G.T. Road (South), Howrah, once per week for four months as directed by EIC.

## 3. Submission of Quotation:-

Quotations are to be submitted of along with following documents

- i. The firm shall have valid and / or renewed trade license.
- ii. The intending tenderer shall have valid up to date clearance certificates of professional tax. If up to date PTCC is not obtained then receipt copy of tax deposit Challan from the date of PTCC last issued / obtained to the current year shall have to be produced.
- iii. The firm shall have Valid GST Registration with Certificate.
- iv. The firm shall have valid PAN issued by GOI with IT (last three year's) Return.
- v. Quotationer should have successfully completed similar type of Job/ work or similar nature of job during last 5 (five) years prior to the date of this notice  
The work completion certificate (Credential) must specify detailed nature of job completed, Tender value of job, Final Bill value, date of commencement and date of completion of work.  
In case of Running work, only those tenderers who will submit the certificate of satisfactory running work from the concern competent engineering authority will be eligible for participating in the tender. In the certificate, it should clearly states that the work is in progress satisfactorily, detailed nature of job of execution, Tender value of job, date of commencement of work, date of completion of work, up-to-date running Bill value and also that no penal action has been initiated against the executed agency.
- vi. All the pages of Tender paper and all the documents (submitted as Bid Document) including photo copies must be signed by the authorized representative on the body of such documents.  
Submission false document by tenderer is strictly prohibited and if found action may be referred to the appropriate authority for persecution as per relevant I.T. Act. with forfeited of earnest Money forthwith.

Qualified agency has to execute 05 (Five) copies of formal tender with KMDA against fee @ Rs 300/- per copy.

#### 4.0 Earnest Money Deposit:

The tenderer shall have to deposit earnest money of 2% (two percent) quoted rate in the form of bank draft from any Nationalized bank drawn in favor of KMDA payable at Kolkata.

#### 5.0 Security Deposit :


An amount @ 8% of the work /supply will be recovered from the bill of the L1 bidder. 2 % already with the department as EMD shall together form 10% security deposit which will be retained for 3 (Three) months from the date of completion of the work as certified by EIC.

#### 6.0 Rates inclusive of all charges:

As stated elsewhere the rate quoted by the tenderer shall be inclusive of all elements of taxes, GST and duties, demands. The tenderer shall include GST, LW cess etc. as applicable, octroi if any, toll, ferry charges, local charges, royalties, service taxes, turn over taxes, custom duties and all other charges as applicable.

7.0 Contractor's premises, the Contractor will be responsible for any loss or damage caused in the course of transpiration or work and will make need of the same at their cost.
