Executive Engineer, Div-III, W&S Sector, KMDA invites sealed tender in KMDA Form No 1 from reliable, resourceful, bonafide and experienced Firms/ Individual contractor who have successfully completed similar nature of works is eligible for the under mentioned works at least 40% (forty percent) of the estimated value in a single contract within last 5 (five) years from the date of issue of this NIT or credentials of 2(two) similar nature of completed work, each of the minimum value of 30% of the estimated amount put to tender during 5(five) years or credentials of one single running work of similar nature which has been completed to the extent of 80% or more and value of which is not less than the desired value in Government / Government Undertaking /Autonomous Bodies / Statutory Bodies and local Bodies etc.

Issue of Tender Documents:

If required tenderers are bounded to produce original certificates during verification of certificates of the copy.

Photo copies of the following documents must be submitted:

- (1) Valid PAN Card.
- (2) Valid Income-Tax clearance certificates of last Three (3) years (for last 3 years in SARAL).
- (3) GST registration certificate.
- (4) Up to date professional Tax Challan.
- (5) Completion certificate/Payment Certificate showing execution of similar nature of job value not less than 40% of the estimate amount put to tender.
- (6) Registration certificate and / or Trade License of the company.
- (7) Audited Balance Sheets of last three financial years with auditor’s certificate regarding annual Turnover from contracting business in each year.
- (9)Current Bank Solvency Certificate from any Nationalized/Scheduled Bank.
- (10) Partnership deed (in case of partnership firm) with written power of attorney of signatory of The deed.

Note: Failure of submission of any one of the above mentioned documents will render the tender liable to summary rejection.

Terms & conditions:

1. Supply of all labour, tools & tackles, instruments, equipment, accessories, as are needed to complete the job, in a manner as specified to the entire satisfaction of the E.I.C.
7. The contractor will be full responsible for safety and security of the labours, work men who will be involved at this work. Also, contractor will take care about surroundings areas and locality against any incident or accident during such work.
8. The tenderer should be on the basis of the schedule of rates enclosed with the tender paper. The contractors are to quote a particular percentage higher or lower than or at par with the schedule of rates.
9. The Tender receipt by the Tendering authority from one other location will be opened at scheduled date and time in presence of the intending tenderers.
10. No mobilization advanced will be paid under any circumstances.
11. Security Deposit towards performance Security amounting to 8% of the work value shall be deducted from each R/A Bill as per prevailing order. No interest will be paid on Security Deposit. Earnest Money @ 2% of the estimated value put to tender would be converted into Security Deposit in case of the successful bidder. The Security period will be 3 (Three) months from the date of completion of the work.
