**DETAILS NOTICE INVITING e-TENDER**

1. Invitation:-Executive Engineer, Division-I, RE PART, HOUSING Sector, KMDA invites online e-tender from reliable, resourceful, bonafied and experienced firms/companies/individual contractors, who have completed the similar nature of work like any type of **RCC structural work/Building construction work/Building repairing with allied works in a single tender within the last 05 (five) years** from the date of issue of this NIT. Completed the above stated works, as per documentary evidence submitted, in any Govt./Semi-Govt./Govt. Undertakings/Autonomous Bodies (constituted under the State/Central statute)/ Statutory Bodies and Local Bodies are eligible for the under mentioned works.

2. Intending bidder may download the tender documents from the website <https://wbtenders.gov.in> directly with the help of Digital Signature Certificate.
3. **EMD (Earnest Money Deposit) Shall be deposited through online only as per requirement of the system.**
4. Submission of Tender- a) Pre-qualification/Technical Bid and Financial Bid both will have to be submitted online concurrently duly digitally signed in the website <https://wbtenders.gov.in> as per time schedule stated herein under. Time will be reckoned as per Server Clock. b) The Financial Bid of the prospective tenderers will be opened only if the tenderer qualifies in the Technical Bid. The decision of the Tender Inviting Authority will be final and binding to all concerned and no challenge against such decision will be entertained.

Tenders will be opened by the **Executive Engineer, Division-I, RE PART, HOUSINGSECTOR, KMDA** or his authorized representative in presence of tenderer or their authorized representatives who may like to be present.

## 6. Eligibility criteria for the bidders :-

### a) Technical:-

- i. Intending tenderers should produce credentials of a similar nature (as mentioned above Sl. No. 1) of completed work in a single tender for the minimum value of 40% of estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice; or
- ii. Intending tenderers should produce credentials of 2(two) similar nature (as mentioned above Sl. No. 1) of completed work, each of the minimum value of 30% of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice; or,
- iii. Intending tenderers should produce credentials of one single running work of similar nature (as mentioned above Sl. No. 1) which has been completed to the extent of 80% or more and value of which is not less than the desired value at 6.a.(i) above;

In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, Or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and-also that no penal action has been initiated against the executing agency, i.e., the tenderer.

### b) Financial:-

- i. The bidder should have minimum average annual turnover of **Rs.8.53 (Eight Point Five Three) Lakhs only during three consecutive financial year within last 5 (five) years ending on 31.03.2021. (Relevant documents shall be uploaded by the bidder through Tender Portal ([www.wbtenders.gov.in](http://www.wbtenders.gov.in)) for checking the eligibility).**
  - ii. Bank Solvency Certificate, minimum value of **Rs. 2.84 (Two Point Eight Four) Lakhs only** or above and date of which shall not be more than 6 (six) months before the date of issue of the e-NIT.
- c) Scanned copy of original documents i.e. Valid PAN issued by the IT Deptt., Govt. of India, Latest Professional Tax Paid Challan as per enrollment rate slab & P-TAX Enrollment Certificate, Valid income tax (For Last 3 yrs ), Valid 15 digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017, Last 3 yrs Audit balance sheet (if applicable), Credentials (Work Order, & Completion Certificate of the same work as per Sl-1 & 6,(a) of this NIT ), Employees PF and ESI , Bank Solvency Certificate as per Sl-6,b(ii), Valid trade license of the company must be submitted duly digitally signed at desired location in the website <https://wbtenders.gov.in>.
- d) The following clause shall be included in all the contracts to be executed for (i) procurement of goods and services and (b) works related contract involving supply of goods and services by contractor: "Tax invoice (s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017."
- e) Scanned Copy of one affidavit before Notary will have to be submitted mentioning the correctness of the documents and a declaration of penalty debarment etc. faced by him under any Govt./Semi-Govt./Govt. Undertaking /Autonomous body(constituted under the State/Central statute)/ Statutory Bodies and Local Bodies, submitted through online at desired location ( as per Annexure-I) and declaration by the tenderer as per prescribed format ( Annexure-II).
- f) Partnership Firm should submit necessary deed at desired location through on line.

- g) **Earnest Money:**-The initial Earnest Money shall be of Rs.56,837/- ( Rupees Fifty Six Thousand Eight Hundred Thirty Seven Only), shall be deposited through online as per the system in the tender portal i.e (www.wbtenders.gov.in) in the respective field, failing which the tender shall be rejected. The successful tenderer shall have to submit an additional amount against Earnest Money @ 2% of the awarded tender value if that exceed already deposited EMD the balance amount will be deposited in the form of Demand Draft drawn in favour of “KMDA” of any scheduled Indian Bank at Kolkata.

7. **a) List of common documents shall have to be uploaded by each tenderer at the time of submission of Tender through online:-**

- ii. Audited Balance Sheet, if applicable ( For last 3yrs, ending on 31.03.2021)

- iv. Latest Professional Tax Paid Challan as per enrollment rate slab& P-TAX Enrollment Certificate.
- v. Valid 15 digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017.
- vi. Latest Valid Trade License.
- vii. Scanned Copy of one original affidavit before Notary will have to be submitted as per (Annexure-I)&Declaration by the tenderer as per prescribed format (Annexure-II).
- viii. **Technical Credential:-**  
Work Order & Completion Certificate of the same work complying as per Sl-1 & 6,(a) of this NIT.
- ix. Bank Solvency Certificate as Sl-6,b(ii) in prescribed format (Annexure-III)
- x. Employees PF and ESI .

**b)List of documents shall have to upload by a Partnership Firm in addition to Sl. No. 7.a)**

- i) The power of Attorney for the firm for signing the tender by a partner.
- ii) Partnership Deed.

8. **Time of completion:** Time of completion shall be 02(Two months) from the date of issuance of work order.

9. **Provision of Defect Liability Period & Refund of Security Deposit :**

Prospective bidders shall have to execute the work in such a manner so that appropriate service level for the stipulated work is to be maintained during stipulated contractual period till actual date of completion and a **Defect Liability Period for the work is 01(One) year** from the date of actual successful completion of the work. If any defect/ damage is found during the period as mentioned above, the contractor shall make good the same at his own expense to the specification at par with instant project work, or in default, the Engineer-in-charge may cause the same to be made good by other agency and deduct the expense (for which the certificate of the Engineer-in-charge shall be final) from any sums that may be then, or at any time thereafter become due to contractor, or from his security deposit, or the proceeds of the sale thereof, or of sufficient portion thereof or from any pending dues for any contract with KMDA . Full security deposit shall be refunded to the contractor on expiry of **one year** from the actual date of completion of the work.


10. **Additional Performance Security:-**

The Additional Performance Security @10% of the tendered amount shall be obtained from successful bidder, if the accepted bid value is 80% or less of the estimate put to tender, Additional Performance Security shall be equal to 10% of the tendered amount and be submitted in the form of Bank Guarantee from any Scheduled Bank before issuance of the Work Order. If the bidder fails to submit the Additional Performance Security within seven working days from the date of issuance of Letter of Acceptance, his earnest money will be forfeited and other necessary action as per NIT like Blacklisting of the contractor, etc, may be taken. The said Bank Guarantee shall have to be valid upto the end of the Successful completion of the work and shall be renewed accordingly, if required. If the bidder fails to complete the work successfully, the Additional Performance Security

shall be forfeited at any time during the pendency of the Contract period after serving proper notice to the contractor.

11. **Language of Tender:-** The tender shall be submitted in the prescribed form in English. All literatures and correspondence in connection with the tenders shall be in English.
12. **Others :-** The Tender Notice along with other documents like **Tender Form No. - 1 KMDA, Technical Specification, Special Terms and Conditions, BOQ, Addendums and corrigendum's etc.** whatever documents uploaded by the department concerned thereto shall be part and parcel of the Tender. The agency must go through carefully the Special Terms and Conditions uploaded by the department before quoting his rate. **All the bidders are requested to upload only necessary documents for the tender. Uploading unnecessary/irrelevant documents may create problem in the evaluation process. In that case any inadvertent mistake during evaluation of the tender, Tender Inviting Authority (TIA) will not be responsible.**
13. **Penalty for suppression / distortion of facts:** If any document/statement/information submitted by any bidder in the tender is found to be false, the Tender Inviting Authority (TIA) will take legal action against the bidder including forfeiture of Earnest Money Deposit (EMD).”
14. The tender inviting authority (TIA) reserves the right to accept or reject any or all the tenders without assigning any reason what so ever.
15. **While evaluation, the committee may summon of the tenderers & seek clarification/information or additional documents or original in hard copy/soft copy, if any shortfall documents may required by the TIA it shall only be uploaded in Tender portal (www.wbtenders.gov.in) within the stipulated time period.**
16. **Any of the documents already submitted/seeking by TIA during Bid evaluation, if they are not produced within the stipulated time frame, their bid will liable for rejection.**
