- (5) Completion certificate/Payment Certificate showing execution of similar nature of job value not less than 40% of the estimate amount put to tender.
- (6) Registration certificate and / or Trade License of the company.
- (7) Audited Balance Sheets of last three financial years with auditor’s certificate regarding annual Turnover from contracting business in each year.
- (9) Current Bank Solvency Certificate from any Nationalized/Scheduled Bank.
- (10) Partnership deed (in case of partnership firm) with written power of attorney of signatory of The deed.

**Note: Failure of submission of any one of the above mentioned documents will render the tender liable to summary rejection.**

11. The Security period will be 3 (Three) months from the date of completion of the work.


