- 3) Date and time of submitting of quotation : At 3.00 p.m. to 28.11.2023
- 4) Date and time of opening of quotation : At 3.00 p.m. on 29.11.2023

Tenders will be opened by the Executive Engineer, SCD-II, R&B SECTOR, KMDA or his authorized representative in presence of tenderer or their authorized representatives who may like to be present.

Eligibility criteria for the bidders:-

- 2) The intending bidders must have successfully completed similar type of work of value not less than 50% in a single contract within the last 5(five) years from the date of publication of this NIT.
 - A) Bidder should have PAN card, P. Tax, Valid income tax return (For Last 3 yrs), Valid 15 digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017 & Latest Valid Trade License, Credentials, Work Order etc.,
 - B) One affidavit before Notary will have to be submitted mentioning the correctness of the documents and a declaration of penalty debarment etc. faced by him under any Govt./Semi-Govt./Autonomous body/Institution.
 - C) **Earnest Money:-** The tenderer shall have to deposit **requisite earnest money along with the tender document** in prescribed manner failing which the tender shall be rejected. The balance earnest money if any to fulfill 2(two) percent of the tender value is to be deposited at the time of execution of formal agreement.
 - 3) The Executive Engineer, SCD-II,R&B KMDA reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained. During scrutiny, if it is come to the notice to tender inviting authority that the credential or any other papers found incorrect/manufactured/fabricated, that tenderer will not be allowed to participate in the tender and that application will be out rightly rejected without any prejudice with forfeiture of earnest money forthwith.
 - 4) Before issuance of the Work Order, the tender inviting authority may verify the credential & other documents of the successful bidder if found necessary. After verification, if it is found that such documents submitted by the successful bidders either manufacture or false in that case Work Order will not be issued in favour of the bidder under any circumstances.
 - 5) **Language of Quotation:-** The quotation shall be submitted in English. All literatures and correspondence in connection with the quotation shall be in English.
 - 6) Successful bidder shall have to execute an agreement in the prescribe format which will be available from the office.
