The tenderer must apply to the tender inviting authority for permission to purchase tender documents. **Along with the application, they have to submit copies of PAN Card, GST Registration certificate and Professional tax clearance certificate, valid Electrical contractor's license, Workmen permit and completion certificate / payment certificate of execution of similar nature of jobs of value not less than 40% of the amount put to tender within last five years to carry out the job.** All papers should be duly signed in all pages by the tenderer or his authorized representative subscribed as 'Submitted by me'.

The tenderer must submit an earnest money as specified at column no.4 in the shape of Bank Draft/Pay order drawn from a Scheduled Bank payable at Kolkata in favour of 'KMDA' along with the tender documents. The successful tenderer will have to provide 10% of the tendered amount (contract price) as security deposit of the work. In case of successful tenderer, the earnest money deposited with the tender, will be converted into the part of the Security Deposit.

The tenderer shall quote his offered rate both in figure and in word in percentage Above/At Par/Below of the estimated value put to tender. The rate quoted by the tenderer shall be inclusive of GST, Income tax, Cess, local charges and all other charges, duties and demands as applicable. Nothing extra will be paid on such account.

Income tax, Cess etc. will be deducted from contractor's bill at the rate in force at the time of billing in accordance with orders/circulars of Govt. of West Bengal and Govt. of India during contractual period.

The successful bidder have to submit GST Invoice for the job at the time of billing.

The complete sealed tender papers shall be submitted/dropped in the tender box kept in the office of the chamber of the following officers:- a) The Superintending Engineer, MC-I, E-M Sector, KMDA, b) The Executive Engineer, Mechanical Division-I, E-M Sector, KMDA within the prefixed date and time.
