- (2) Valid Income-Tax clearance certificates of last Three (3) years (for last 3 years in SARAL).
- (3) GST registration certificate.
- (4) Up to date professional Tax Challan.
- (5) Completion certificate/Payment Certificate showing execution of similar nature of job value not less than 40% of the estimate amount put to tender.
- (6) Registration certificate and / or Trade License of the company.
- (7) Current Bank Solvency Certificate from any Nationalized / Scheduled bank.
- (8) Partnership deed (in case of partnership firm) with written power of attorney of signatory of the deed.

Note: Failure of submission of any one of the above mentioned documents will render the tender liable to summary rejection.

- **1.** Supply of all labour, tools & tackles, instruments, equipment, accessories, as are needed to complete the job, in a manner as specified to the entire satisfaction of the E.I.C.
