#### Title of the Land:

HIT WING, KMDA is and shall continue to be the absolute owner of the Stall no.18,19&20under Buckland Bridge (Rishi Bankim Setu) allotted to the successful bidder.

#### 1) Eligibility criteria for participation in the tender:

- **1.1 e-**Quotations are invited by Superintending Engineer, HIT WING, KMDA from Firms (Proprietorship / Partnership) / Societies / Company/agency / NGO's / individuals/ registered Co-operative Society who are eligible to participate in the tender. Any agency willing to take part in the quotation process should have executed similar nature of work.
- **1.2** Each Co-operative Society willing to participate in tender for Temporary license agreement of stall no. 18,19 & 20 under Buckland Bridge (Rishi Bankim Setu) must submit/enclose currently valid registration certificate issued by Assistant Registrar of Co-Operative Society/Deputy Registrar of Co-Operative Society under the Co-Operative Societies Act. etc.
- **1.3** The agency /allottee / licensee who has already been debarred may not be allowed to participate in any tender till the embargo is over.
- 1.4 The intending bidder who has been debarred either by KMDA or by any Govt. Department, Statutory Body, Organization etc. will not be eligible for participating in the tender. Bidder shall submit a declaration to that effect that they are not under debarred by any such authorities and submitted documents by them are true and genuine and consequence of any eventuality will be solely borne by them. (Annexure-I)
- **1.5** Consortium / Joint Venture of establishments or Agencies are not eligible to participate in the tender.
- **1.6**Also note that in future no single stall from the lots/combined stall can be surrendered. If any licensee wants to surrender, then the whole lot has to be surrendered. Surrender, if any shall be considered for acceptance with at least three months prior notice and clearance with up to date payment.

- **1.7**The participating bidder must possess Income Tax Acknowledgement Receipt for the last three Assessment years, Professional Tax Deposit Challan for the current year, PAN Card, GSTIN Number.
- 1.8The prospective bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. (A declaration in this respect through affidavit in original for each bid/tender has to be furnished by the intending bidders without which the Technical Bid shall be treated as non-responsive).(Annexure-II).
- **1.9**Must possess valid Certificate of Enlistment (commonly known as trade license) issued by Local Authorities. Registered Partnership Deed for Partnership Firm only along with Power of Attorney if required, is to be submitted along with the application. The company shall furnish the copy of Registration of Company (ROC), LLP, Master Data, copy of Board Resolution etc.

#### 2. Roles and Responsibilities:

- **2.1**)The financial proposals will be evaluated on the basis of the Yearly Charge for the 1st year payable to HIT WING, KMDA, to be quoted by the Bidders. The bidder who will quote the highest Yearly Charge for the 1st year will be the successful bidder. The successful bidder has to pay first Yearly charge (quoted value) in Indian Rupees through demand draft drawn on any Nationalized Bank in favour of 'HOWRAH IMPROVEMENT TRUST' Payable at 'HOWRAH', prior to the date of issuance of the work order. In subsequent years of the **9** (NINE) years License period, the yearly charge must be paid within **14** (Fourteen) working days from the date of issuance of the work order. If bidder fails to pay yearly charge within 14 days from 2<sup>nd</sup> year and onwards, they are allowed to deposit the amount with 6.25% annual interest for the delay period maximum up to 60(Sixty) days from the starting of 2<sup>nd</sup> year. In that conditions the bidders have to appeal for that before due date.
- **2.2**)After expiry of the next 60 (SIXTY) Days, HIT Wing/KMDA will reserve the right to cancel/ terminate the Agreement without any further notice and to take over possession of the Stalls. without any prejudice to the rights of the HIT Wing/KMDA as per the provisions of the Agreement and the license will hand over possession of the stalls peacefully toHIT Wing/KMDA.
- **2.3**)The Yearly Charge paid in every subsequent year on or before 14 (Fourteen) working days from the day of issuance of the work order will be enhanced throughout the License period @ 5% (Five percent) of previous year's Yearly Charge. Thus, the increment of 5% compounded annually is applicable from 2<sup>nd</sup> Yearly Charge payment onwards.
- **2.4**)All demand should be sent to the registered Address/e-mail ID of each and every licensee/ allottee / agency etc. on 1st day of the year ( from the date of issue of work order) and this demand shall be deemed as proper service of demand notice.

The agency shall be liable to pay the requisite amount of yearly rent of the every year along with @18% GST extra on the said yearly rent. Payment of GST shall be made in Indian Rupees through demand draft drawn on any Nationalized Bank in favour of 'KMDA' Payable at 'KOLKATA'.

The intimation regarding change of address shall be given to the office of T.I.A of HIT WING, KMDA with supporting documents for necessary amendments in the registration certificate for better communication to the concerned contractor/licensee. If it/he/she does not communicate about any

changes of the establishment, all information or communication will be made by HIT WING,KMDA at the recorded address of the contractor/agency/licensee.

**2.5**) No subletting of Stall: No subletting of the stall, fully or part thereof, is permissible. The Licensee shall manage the stall by himself/itself or through his/its employees but shall not be allowed to sublet the stall to any other person/agency/firm. At any point of time if it is found that the Licensee has been sub-let the zone/stretch/location partly or fully, allotted to him/her/it, current contracts) shall be liable for cancellation with the forfeiture of Earnest Money.

#### 2.6) Trading of any hazardous/inflammable/food items will not be allowed in these stalls.

2.7) The successful agency shall fix Display Board duly approved by KMDA/HIT Wing.

#### 3). <u>Description of the works</u>

- **3.1** The establishments/firms/Co-operative/Company/Agency/NGOs shall be permitted to participate in the
- e-NIQ of Temporary license agreement of stall no. 18 ,19 & 20 under Buckland Bridge (Rishi Bankim Setu) which shall be allotted on 'as is where is' basis.
  - **3.2**In no case the allotted stall area should go beyond the demarcated area. Moreover, If the agency violates any of the provisions laid down in the NIQ/NIT, KMDA reserves the right to terminate the agreement at any point of time after giving 1 (one) month prior notice with the forfeiture of Earnest Money.

All terms and conditions as noted in this tender document should be strictly adhered.

#### 4.TENURE& PRIMARY TERMS AND CONDITION:

successful bidder will be allotted the stalls for a period of **9** (**Nine**) years and of time under any exceptional circumstances, if agreed by both sides, subject to discretion of the authority depending on the satisfactory performance by the already selected & awarded bidder and subject to approval of competent authority, with mutual consent of both the parties with the same terms & conditions.

- All demand will be sent to the registered address, e-mail ID of each and every licensee / allottee / agency etc. on 1st day of each year and this demand shall be deemed as proper service of demand notice. He shall be liable to pay the amount within 14(Fourteen) days of the issue of demand notice.'
- HIT WING,KMDA has every right to cancel without any Penal charge any stall at any point of time, if situation so demands.

#### 5. WHO CAN APPLY:

Firms (Proprietorship / Partnership) / Societies / Company/agency / NGO's / individuals/ registered Cooperative Society.

After submission of tender document if it is found that the applicant is already blacklisted / debarred defaulter firms / individuals, said application will be treated as cancelled without any reference including forfeiture of EMD.

#### 6. HOW TO APPLY/ MODE OF APPLICATION:-

# 7. Modality of Inviting Tender:-

- A. **NIC TENDER PORTAL** i.e (<u>www.wbtenders.gov.in</u> and <u>www.kmda.wb.gov.in</u>). There is no provision of submission of tender in any hard copy.
- B. Intending bidder may download the quotation documents from the website <a href="https://wbtenders.gov.in">https://wbtenders.gov.in</a> and <a href="www.kmda.wb.gov.in">www.kmda.wb.gov.in</a> and directly with the help of Digital Signature Certificate.
- C. EMD (Earnest Money Deposit) Shall be deposited through online only as per requirement of the system. in the tender portal in the respective field, failing which the tender shall be rejected.
- D. Submission of Tender- a) Pre-qualification/Technical Bid and Financial Bid both will have to be submitted online concurrently duly digitally signed in the website https://wbtenders.gov.in and <a href="https://www.kmda.wb.gov.in">www.kmda.wb.gov.in</a> as per time schedule stated herein under. Time will be reckoned as per Server Clock. b) The Financial Bid of the prospective tenderers will be opened only if the tenderer qualifies in the Technical Bid. The decision of the Tender Inviting Authority will be final and binding to all concerned and no challenge against such decision will be entertained.
- E. Financial bid of tenderers declared technically eligible by the Tender Evaluation Committee and it will be opened electronically from the web portal on the prescribed date and time.
- F. During uploading of documents all bidders should be careful enough to assign the name of the file that it so that it can be easily understand about its content. Misleading file name may produce error in evaluation process for which Tender inviting Authority will not be responsible.
- G. All the bidders are requested to upload only necessary documents for the tender. Uploading unnecessary/irrelevant documents may create problem in the evaluation process. In that case any inadvertent mistake during evaluation of the tender, Tender Inviting Authority (TIA) will not be responsible.

#### **8. SELECTION OF BIDDER:**

Evaluation and selection procedure will be made as per financial norms. Only H1 bidder will be entitled for award of the license. If the successful bidder is un-willing to accept the offer letter, the successful bidder will be debarred for participating in NIQ for the next tender and will be

debarred for a period of 1 (one) year from participating any tender in KMDA including forfeiture of Earnest Money Deposit (EMD). Qualified agency has to execute 04 (Four)copies of formal tender with KMDA against fee @ Rs 300/- per copy. The quoted amount of the successful bidder should be either equal to or above the reserved yearly charges as mentioned in the NIT/NIQ document. Any quoted rate below the reserved yearly charges (4,87,800.00) will not be accepted.

#### 9. MODE OF PAYMENT:-

#### 1) AMENDMENT OF TENDER DOCUMENT:-

Addendum / Corrigendum will also be available in the <a href="https://kmda.wb.gov.in/">https://kmda.wb.gov.in/</a>.andhttps://wbtenders.gov.in The Prospective bidders are required to download the same from the website and quote their rate accordingly in the respective field considering the all Addendum/Corrigendum published in the website within the last date of submission of Bid.

To give prospective tenderers reasonable time in which to take the Addendum / Corrigendum into account in preparing their tenders, extension of the deadline for submission of Tenders may be given as considered necessary by HIT WING, KMDA.

#### 2) Earnest Money Deposit (EMD):

**Earnest Money deposit (EMD)** is to be remitted by the Bidder in favour of **KMDA**. Payable at **KOLKATA**, as mentioned in the **column 4** above through Net- Banking/ RTGS/NEFT in respect of the Tender ID, as per requirement of e-Procurement System of Government of West Bengal (https://wbtenders.gov.in/).

In addition, instruction by the Finance Department **MEMORANDUM**, vide no. - **3975-F(Y)**; **Dated, 28th July, 2016** to be followed for ready reference and guidance.

The EMD for successful bidder will be converted to Security Deposit which will be released after until the successful completion of the contract period.

#### 3) (a) Refund of Earnest Money:

The Earnest Money of all the Bidder except successful bidder i.e. H1 will be returned after execution of agreement with the successful bidder i.e. H1.

- b) The Earnest Money is liable to be forfeited:
- i) If any tenderer,
- withdraws tender after its submission, or,

- 5) The intending Bidders should clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Department. The TIA HIT Wing/KMDA reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Tenderer at the stage of Bidding.

#### 6) KMDA'S RIGHT ON ACCEPTANCE OF ANY TENDER

The competent authority of KMDA does not bind itself to accept the highest or any other tender and reserves to himself the authority to reject any or all the tenders received without the assignment of any reason. All tenders in which any of the prescribed conditions is not fulfilled or any condition is put forth by the tenderer shall summarily be rejected.

- 7) Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in Eligibility criteria for participation in the tender' stated in before tendering the bids.
- 8) Conditional / Incomplete tender will not be accepted under any circumstances.
- 9) The intending tenderers are required to quote the rate clearly.
- 10) During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
- 11) TIA,HIT WING, KMDA, reserves the right to cancel the N.I.T. due to unavoidable circumstances without assigning any reasons whatsoever and no claim in this respect will be entertained. In this regard no interest will be payable on the Earnest Money.
- 12) Before issuance of the WORK ORDER, the tender inviting authority may verify the credential and other documents of the accepted tenderer, if found necessary. After verification if it is found that the documents submitted by the accepted tenderer is either manufactured or false in that case work order will not be issued in favour of the said Tenderer under any circumstances.
- 13) If any discrepancy arises between two similar clauses on different notifications, the clause as stated in later notification will supersede the former one as per clause of condition precedence.

- 14) The eligibility of a bidder will be ascertained on the basis of the documents in support of the minimum criteria as mentioned above and the declaration executed through prescribed affidavit (in original for each bid/tender) in non-judicial stamp paper of appropriate value duly notarized.
