- (4) Up to date professional Tax Challan.
- (5) Completion certificate/Payment Certificate showing execution of similar nature of job value not less than 40% of the estimate amount put to tender.
- (6) Registration certificate and / or Trade License of the company.

(7) Current Bank Solvency Certificate from any Nationalized/Scheduled bank.

(8) Partnership deed (in case of partnership firm) with written power of attorney of signatory of the deed.

**Note: Failure of submission of any one of the above mentioned documents will render the tender liable to summary rejection.**
