If required tenderers are bounded to produce original certificates during verification of certificates of the copy.

Photo copies of the following documents must be submitted:

- (1) Valid PAN Card.
- (2) Valid Income-Tax clearance certificates of last Three (3) years (for last 3 years in SARAL).
- (3) GST registration certificate.
- (4) Up to date professional Tax Challan.
- (5) Completion certificate/Payment Certificate showing execution of similar nature of job value not less than 40% of the estimate amount put to tender.
- (6) Registration certificate and / or Trade License of the company.
- (7) Partnership deed (in case of partnership firm) with written power of attorney of signatory of the deed.

Note: Failure of submission of any one of the above-mentioned documents will render the tender liable to summary rejection.

Terms & conditions:

1. Supply of all labour, tools & tackles, instruments, equipment, accessories, as are needed to complete the job, in a manner as specified to the entire satisfaction of the E.I.C.
2. The contractor will be full responsible for safety and security of the labours, work men who will be involved at this work. Also, contractor will take care about surroundings areas and locality against any incident or accident during such work.
3. The tenderer should be on the basis of the schedule of rates enclosed with the tender paper. The contractors are to quote a particular percentage higher or lower than or at par with the schedule of rates.
