Scope of work:

- 1. Construction of two standard temporary type main entry/exit gates (gantry type) one is 27'6"x4'x11' (H) and other one is 16'6"x3'x11' (H) with good quality floral decoration.
- 2. Three side open (covered roof) temporary stage with backdrop of approx. 19'x 14'x 15' (H) and VIP chair & center tables & other chairs with carpet and good quality floral decoration.
- 3. Temporary Pandel of office (16'x18'x17' (H)) and Guest lounge (60'x18'x17' (H) with required nos. of Sofa, VIP chairs and tables & other chairs with floor carpet.
- 4. Temporary covered selling stall- left side of the gate (88'x14'x9'6" (H)) with divider and right side of the gate (23'8"x14'x19'6"(H)) with divider with required chairs and tables.
- 5. Orchid Stall (113'x6'x7' (H)) around the existing building inside the ground.
- 6. Temporary Bonsai stall (45'x6'x4' (H))- Three rows with proper barricading.
- 7. Temporary LED Room- (16'x13'x12'6" (H))
- 8. Cloth fencing with bamboo having total Length 777' and Height 7'.
- 9. Raised covered wooden platform of cactii, succulent, etc with proper barricading.
- 10. Demarcation/Segregation of different Classes (at least 10) of plants with bamboo-ribbon fencing.
- 11. Tentative Cash prize money to the growers of RupeesOne Lakh Twelve Thousand Five Hundred for different Sections. Payment shall be made as per actual.
- 12. Tentative Conveyance allowance of growers and judges of Rupees Five Lakh approx. Payment to be made as per actual as decided by the committee.
- 13. Dinner @ Rs 200/- approx and breakfast/tiffin @Rs 100/- approx per packet of approx 150 growers/drivers.
- 14. Refreshment of Judges and other dignitaries @Rs 400/- approx per packet of approx 75.

- 15. Refreshment with good quality tea, biscuits, snacks, drinking water etc to the dignitaries and others throughout the show period to be provided by the bidder.
- 16. Two bio toilets with all facilities to be installed with proper maintenance staffs of each toilet over the period of five days (16th to 19th January 2025).
- 17. Five labourer including two skilled Malis for nourishing and watering of the plants should be provided by the bidder as well as sweeping of the premise etc of the program from 16th to 19th January 2025.
- 18. Providing "Section Bamboo Sticks" of 1.5 feet height 500 Nos.
- 19. Various types of stationaries, mementos, certificate, badges, uttoriyo, files, flower bouquet etc should be provided by the bidder.
- 20. Honourarium of Rupees Fifty Thousand for engaging one horticulturist for guidance in arrangement of the flower show.
- 21. Any major undulations found in the ground should be leveled as per instruction of E-I-C.

 - 2. Earnest Money deposit (EMD) is to be deposited through Bank Draft in favour of KMDA payable at KOLKATA.
 - 3. Submission of Quotation: -a) Pre-qualification/ Technical Bid and Financial Bid both have to be submitted online concurrently duly digitally signed in the website https://wbtenders.gov.in as per time schedule started herein under. Time will be reckoned as per server clock. b) The Financial Bid of the participant Quotationers will be opened only if the quotationer qualifies the Technical Bid evaluation.

5. Eligibility criteria for the bidders:-

- A. Scanned copy of valid up to date Professional Tax, GST as per latest Govt. order and PAN card issued by Income Tax Department, Valid Income tax (For last 3yrs FY 21-22,22-23 & 23-24), Last 3yrs. (as above FYs) audited balance sheet, Credentials, and other supporting documents, Registration Certificate and/or trade license of the company must be submitted duly digitally signed at desired location in the website https://wbtenders.gov.in
- B. Scanned copies of one Affidavit before Notary will have to be submitted mentioning the correctness of the documents and a declaration of penalty debarment etc. faced by him under any Govt./ Semi Govt./ Autonomous body/Institution through online at desired location.

- C. Partnership firm/ Consortium should submit necessary deed at desired location through online.
- 6. For successful bidder, the said Earnest Money will be converted to Security Deposit and that amount will be refunded without any interest only after successful completion of the contractual period.

 - ix. Work Order with completion certificate for the work in technical credential.
 - x. Bank Solvency for 10% of the estimated amount not more than 6(Six) months old on date of publication of e-NIT.

 - i) The power of Attorney for the firm for signing the Quotation by a partner.
 - ii) Partnership Deed.

 - c) List of documents shall have to upload by a Joint Venture/Consortium in addition to Sl. No. 8.a)
 - i) Copy of MoA/MoU on a stamp paper of Rs.100.00 outlining the joint interest to work on the project and specifying the other terms of agreement.
- 8. The quotation should be submitted in the prescribed form in English. All literatures and correspondence in connection with the quotations shall be in English.
- 9. The Quotation Inviting Authority reserves the right to accept or reject any quotation without assigning any reason whatsoever.

10. Terms & conditions:-

Before submitting any bid offer,the intending participants should make themselves acquainted thoroughly with the local conditions prevailing by actual inspection of the site and take into the consideration all aspects including actual size and availability of land, communication facilities, climate conditions etc.. - b. The selected bidder will have to enter into an agreement of contract with KMDA within 15(fifteen) days of issuance of LOI.

- e. The Lowest bidder (L1) will be awarded the work.
