The Tender accepting authority of HIT WING, KMDA reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Tenderer at the stage of Bidding.
- 7. Conditional / Incomplete Tender will not be accepted under any circumstances.
- **8.** During scrutiny, if it comes to the notice of the Tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the Tender and that application will be rejected without any prejudice.
- **9. The Superintending Engineer,HIT WING, KMDA** reserves the right to cancel the NIT due to unavoidable circumstances and no claim in this respect will be entertained.
- **10.** Successful bidder will have to install display board as instructed by Engineer-In-Charge and have to maintain that board at his own cost. No payment shall be made in this regard from KMDA
- 11. Before issuance of the WORK ORDER, the Tender inviting authority may verify the credential and other documents of the Highest Tenderer if found necessary. After verification if it is found that the documents submitted by the Highest Tenderer is either manufactured or false in that case work order will not be issued in favour of the said Tenderer under any circumstances.

a) Intending tenderers should produce credentials of **1** (one) Similar Nature of Completed Work of the minimum value of **30%** of the estimated amount put to tender during last 5(five) years prior to the date of issue of the tender notice; or

- b) Intending tenderers should produce credentials of **2(Two) Similar Natureof completed work** each of the minimum value of **25%** of the estimated amount put to tender during last 5(five) years prior to the date of issue of the tender notice; or
- Intending tenderers should produce credentials of 1 (One) Single Running Work Of Similar
 Nature which has been completed to the extent of 75% or more and value of which is not less than the desired value at (a) above;

Other terms and condition of the credentials :-

- d) Scanned copy of PAN card, Adhar Card, Credentials, BOQ's of the respective credentials, Work Order, Payment certificate, and other supporting documents (Bank Solvency @10% of quoted amount value) of the bidder must be submitted duly digitally signed at desired location in the website https://wbtenders.gov.in.
- e) Scanned Copy of one original affidavit before Notary will have to be submitted as per prescribed format, attached in the tender documents, mentioning the correctness of the documents and a declaration of penalty debarment etc. faced by him under any Govt./Semi-Govt./Autonomous body/Institution through on line at desired location.
- f) Agencies against which departmental proceedings or legal actions are pending or have been identified by KMDA as having violated the terms of existing contract(s) shall be debarred from participating in this bid.
- g) Earnest Money: The tenderer shall have to upload scanned copy of requisite documents in support of submission of EMD(as mentioned in the column-4 of the above table) through online, along with the tender document in prescribed manner failing which the tender shall be rejected. - **14. - 15. Suspension and Debarment of Contractor:- The detailed procedures for taking penal measures of suspension and debarment of suppliers, contractors and consultants delineated in memorandum No. 547-W©/1M-387/15 dated 16.11.2015 and its subsequent amendment notified vide memorandum no. 724-W©/1M-953/19 dated 19.12.2019, of works branch PWD, GOWB shall be followed for debarment and suspension of bidders & agencies selected for executing public works for their false declaration or forgery or falsification of records submitted for failure to execute committed contract or for their failure to perform contractual obligations and thereby resulting delay for execution of public works or execution of faulty works.
- 16. List of common documents shall have to be uploaded by each tenderer at the time of submission of Tender through online:
 - i. Pan Card.
 - ii. Adhar Card
 - iii. Work Order for the work in technical credential.
 - iv. Payment certificate of the said work.
 - **v.** B.O.Q of the similar nature of work.
 - vi. Bank Solvency@10% of quoted amount value.
- 17. Mismatch in Name: -All documents uploaded by the Bidder, in support of his eligibility/credential for Prequalification to participate in this Tender should be same and identical & with Digital signature certificate (DSC). Minor mismatch like "M/S", "Kr/Kumar"," "Co-Op/Co-Operative" etc. has to be legalized /authenticated by the Bidder by uploading of proper Affidavit (duly Notarized) in this regard.
- 18. Neither prospective bidders nor any of constituent partner had been debarred to participate in tender by the KMDA during the last 5 (five) years prior to the date of this NIT. Such debar will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders as per prescribed format without which the Technical Bid shall be treated non-responsive).
- **19.** For (a) Procurement of goods and services and (b) Works related contract involving supply of goods and services by contractor. Tax Invoice (S) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provision of **GST Act 2017**.
- 20. There shall be no provision of Arbitration.
- 21. No Adjustment of Price OR Price Escalation of any kind will be allowed.
- 22. No mobilization advance and secured advance will be allowed.
- 23. Addenda/Corrigenda: During the tenure of the tender if any addenda/corrigenda take place that will be circulated only through the Government e-Procurement system. Contractors are to keep track of all the Addendum / Corrigendum issued with a particular tender and upload the same digitally signed along with the NIT. Tenders submitted without the Addendum / Corrigendum will be informal and liable to be rejected.
- 24. All possible precautions should be taken for the safety of the people and work force deployed at worksite as per safety rule in force Contractor will remain responsible for his labour in respect of his liabilities under the Workmen's Compensation Act etc. He must deal with such cases as promptly as possible. Proper road signs as per P.W.D. practice will have to be made by the contractor at his own costs.
- **25.** The work to be executed with necessary arrangements for safety, machineries, temporary Barricading, labour hutments, electricity and other misc. at contractors own cost. The contractor have to executed the

work at site following all the guidelines of work for the ongoing Covid 19 pandemic situation viz. face mask for every labours, social distancing, application of sanitizer at regular interval etc.

- **26. Bid Validity:** -Bids shall remain valid for a period of **120 days (One Hundred Twenty)** from the last date of submission of Financial Bid / Sealed Bid. If the bidder withdraws the bid during the period of bid validity the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.
- 27. During scrutiny, if it is come to the notice to tender inviting authority that the credential or any other papers found incorrect/manufactured/fabricated, that tenderer will not be allowed to participate in the tender and that application will be out rightly rejected without any prejudice with forfeiture of earnest money forthwith.
 - List of "Technically Qualified Bidders" will be published in the web portal only. Financial Bid will be opened within a short period after such publication. Therefore, Bidders are requested to view the tender status on a regular basis. In case if there be any objection regarding Pre-qualification/ list of "Technically Qualified Bidders", that objection should be lodged to the Chairman, Tender/Bid Evaluation Committee within 24 hours from the date and time of publication of list of qualified Agencies and beyond that time schedule no objection will be entertained by the Tender/Bid Evaluation Committee.
- **28.** Before issuance of the LOI, the tender inviting authority may verify the credential & other documents of the lowest tenderer if found necessary. After verification, if it is found that such documents submitted by the lowest tenderer is either manufacture or false in that case, LOI will not be issued in favour of the tenderer under any circumstances.
- **29. Language of Tender:** The tender shall be submitted in the prescribed form in English. All literatures and correspondence in connection with the tenders shall be in English.
- **30.** Others: The Tender Notice along with other documents like Tender Form No. -1 KMDA, Technical Specification, Special Terms and Conditions, BOQ, Addendum and corrigendum etc. whatever documents uploaded by the department concerned thereto shall be part and parcel of the Tender.
- **31. Declaration:** Tenderer must upload and submit duly digitally signed a declaration as per prescribed format for confirmation of his awareness of the contract.
- 32. The Bank Guarantee shall be returned immediately on successful completion of the contract. If the bidder fails to complete the work successfully, the Additional Performance Security shall be forfeited at any time during pendency of the contract period after serving proper notice to the contractor. Necessary provisions regarding deduction of security deposit from the progressive bills of the contractor as per relevant clauses of the contract shall in no way be altered / affected by provision of this Additional Performance Security.

- a) Opening of Technical Bid:
 - i) Technical bid will be opened by the Superintending Engineer, HIT Wing, KMDA Intending tenderer may remain present if they so desire. Statutory Cover (folder) would be opened first & if found in order and correct Non Statutory Cover (folder) will be opened. If there is any deficiency in the Statutory & Non statutory documents the tender will summarily be rejected.
 - ii) Decrypted (transformed in to readable formats) documents of the non-statutory cover will be downloaded & handed over to the evaluation committee.

SPECIAL TERMS & CONDITIONS

Name of the Work: Temporary License for Pisiculture at Dumurjola, Beside HIT Eco Park, HIT Scheme No.XXV, Dumurjala, Howrah-711104.

Quality is the essence of the service to be rendered. Services are to be performed to the satisfaction of this office. For this purpose, there will be an assessment period of 06(six) months from the period of engagement.

1) **SCOPE OF WORK:**

Pisciculture and maintenance activities in the Dumurjala Jheel.

2) <u>INSTRUCTION TO TENDERER:</u>

- a. The tank/pond/jheel will be given on temporary license solely for the purpose of pisciculture.
 - b. The temporary license shall be for a period of 36(thirty six) months.
 - c. The bidder who will quote the highest total Charge will be the successful bidder. The successful bidder has to pay first Yearly charge (quoted value) in Indian Rupees through demand draft drawn on any Nationalized Bank in favour of 'Howrah Improvement Trust' Payable at 'HOWRAH', In the event of the highest tenderer getting the Work Order, he/she shall have to pay the license fees of each year at the commencement of the contract/agreement. As the contract / agreement will be done for 3(three) years, the successful tenderer shall pay the license fee including 18% GST through demand draft drawn on any Nationalized Bank in favour of 'KMDA' Payable at 'KOLKATA',and Security Deposit as applicable of every year before 30(thirty)days from the commencement of the 2nd and 3rd year of the contract/agreement, failing which the Work Orderwill be summarily rejected without any intimation to the tenderer whatsoever. In the first year of the contract /agreement the license fees shall have to be deposited before getting the Work Order. In the 2nd and 3rd year, the tenderer will be given supplementary Work Order in addition to the Original Work Order after getting the requisite license fees.

The Yearly Charge paid in every subsequent year on or before 30 (thirty) working days from the day of issuance of the work order will be enhanced throughout the License period @ 5% (Five percent) of previous year's Yearly Charge. Thus, the increment of 5% compounded annually is applicable from 2nd Yearly Charge payment onwards.

- d. Bids less than the estimated amount(Reserve Price) –i.e. Rs.6,03,653.00 (Rupees Six Lac Three Thousand Six Hundred and Fifty Three Only) will not be accepted.
- e. Each year (1ST/2ND/3RD) the license fee, GST Charge ,Security Deposit will be calculated by HIT Wing/KMDA and will be informed to the concerned H1 bidder to deposit the said amount.
- f. If the Howrah Improvement Trust requires the tank/pond/jheel for any development work within the license period, the license may be terminated with3(three) months prior notice.
- g. The Licensee shall not allow or assign the tank to any other person during the ongoing temporary license period. In case of any such action and / or transfer, the license shall be terminated revoked forthwith.

- i. If the licensee wants to discontinue from the temporary license within the license period, he shall not be entitled to get any refund or compensation whatsoever in this respect. Any such claim shall not be entertained.
- j. The authorized officers of the Howrah Improvement Trust Shall have the right to inspect the tank/pond/jheel.
- k. Howrah Improvement Trust reserves the right to accept or reject any or all offer without assigning any reason thereof. In addition, office will not entertain any correspondence from bidders in this matter.
- 1. The undersigned reserves the right to negotiate the rates, terms and conditions with the highest tenderer or any of the other tenderers to ascertain the suitability of the acceptable offer.
- m. The contract shall be initially for 3(three) years and may be extended upon satisfactory performance. The authority holds the right to terminate the contract for violation of terms and conditions at any time without any notice.

- 2. The pond/tank will always have to be kept clean and if any garbage is found, it will have to be removed immediately including hyacinths, etc at own cost.
- 3. Prior permission will have to be taken from the Trust for persons entering the tank premises for fishing activity.
- 4. The Trust might start boating activity in the pond/tank at any point of time within the lease period.
- 5. No damage should be caused to the adjacent "HIT Eco Park" of the Trust.
- 6. Regular commercial fishing activity shall not be allowed in the pond/tank.
