- Net banking (any of the banks listed in the ICICI Bank Payment gateway) in case of payment through ICICI bank payment gateway.
- RTGS/NEFT in case of offline payment through bank account in any bank in respect of the Tender ID in favour of KMDA.

4. Submission of Tender:- a) Pre-qualification/Technical Bid and Financial Bid both will have to be submitted online concurrently duly digitally signed in the website <https://wbttenders.gov.in> as per time schedule stated herein under. Time will be reckoned as per Server Clock. b) The Financial Bid of the Participant tenderers will be opened only if the tenderer qualifies in the Technical Bid evaluation. The decision of the Tender Inviting Authority will be final and binding to all concerned and no challenge against such decision will be entertained.

Tenders will be opened by that **EXECUTIVE ENGINEER, BPPD-I, E&AM SECTOR, KMDA** or his authorized representative in presence of tenderer or their authorized representatives who may like to be present.

6. Eligibility criteria for the bidders:-

- The bidders should have the credentials of similar nature of works completed successfully & satisfactorily with the value not less than 40% of the estimated amount put to tender in a single contract or not less than 30% of the estimated amount put to tender in each of two separate tenders. Nature of works should be clearly mentioned.
- Scanned copy of valid up to date Professional Tax receipt Challan, GST as per latest Govt. order and PAN card issued by Income Tax Department, Valid Income tax (For last 3yrs), Last 3yrs. Audited balance sheet, Credentials, Work Order, Payment certificate and other supporting documents, Registration Certificate and/or trade license of the company must be submitted duly digitally signed at desired location in the website <https://wbtenders.gov.in>.

7. Declaration on Notary

Scanned Copy of one affidavit before Notary will have to be submitted **mentioning the e-NIT No.** and the correctness of the documents and a declaration of penalty debarment etc. faced by him under any Govt./Semi-Govt./Autonomous body/Institution through on line at desired location.

- Earnest Money:-** The tenderer shall have to mention the reference detail in support of remitted RTGS/NEFT of requisite EMD against the tender in prescribed location failing which the tender shall be rejected. The balance earnest money if any to fulfill 2(two) percent of the tender value is to be deposited at the time of execution of formal agreement.
- Additional Performance Security:-** On receiving of the bid, If it is found, the Tendered amounts 20% or Below of the Estimated amount, the L1 Bidder should have to deposit Additional Performance Security @ 10% of the Tendered amount in the form of Bank Guaranty in favour of KMDA for the entire contract period within 7(Seven) days from the date of issuance of LOI. The B.G will be returned immediately on successful completion of the contract.

- Valid Renewed Trade License.
- Affidavit before Notary **mentioning the e-NIT No.** and the correctness of the documents and a declaration of penalty debarment etc.
- Reference details of EMD Remittance.
- Work Order with completion/credential certificate & BOQ for the work in technical credential.
- Bank Solvency 10% of the estimated amount not more than 6 months old from the date of publication of tender.

B. List of documents shall have to upload by a Partnership Firm in addition to Sl. No. 9.A

- i. The power of Attorney for the firm for signing the tender by a partner.
- ii. Partnership Deed

10. Language of Tender:- The tender shall be submitted in the prescribed form in English. All literatures and correspondence in connection with the tenders shall be in English.

11. Provision of Defect Liability Period and Refund of Security Deposit: Refund of Security Deposit will only be made after completion of **Defect Liability Period (DLP) of 1(One) Year**. However proportionate security deposit may be released after elapsing of proportionate time as per Notification No. 5784-PW/L&A/2M-175/2017 dt. 12.09.2017 of Principal Secretary, PWD and satisfaction of Engineer-In-Charge.

12. Others:- The Tender Notice along with other documents like **Tender Form No. -1 KMDA, Technical Specification, Special Terms and Conditions , BOQ, Addendum and corrigendum** etc. whatever documents uploaded by the department concerned thereto shall be part and parcel of the Tender. The agency must go through carefully the special Terms and Conditions uploaded by the department before quoting his rate. **All the bidders are requested to upload only necessary documents for the tender. Uploading unnecessary/irrelevant documents may create problem in the evaluation process. In that case any inadvertent mistake during evaluation of the tender Tender Inviting Authority (TIA) will not be responsible.**

13. Declaration: - Tenderer must upload and submit duly digitally signed a declaration as per prescribed format for confirmation of his awareness of the contract.
