- (2) Valid Income-Tax clearance certificates of last Three (3) years (for last 3 years in SARAL).
- (3) GST registration certificate.
- (4) UP to date professional Tax Challan.
- (5) Completion certificate/Payment Certificate showing execution of similar nature of job value not Less than 40% of the estimate amount put to tender/Bank Solvency certificate.
- (6) Registration certificate and/or Trade License of the company.
- (7) Partnership deed (in case of partnership firm) with written power of attorney of signatory of the deed.

Note : Failure of submission of any one of the above mentioned documents will render the tender liable to summary rejection.

1. When the applicant is an authorized signatory, he should submit documents of authorization in his favour along with the application.
2. Supply of all labour, tools & tackles, instruments, equipment, accessories, as are needed to complete the job, in a manner as specified to the entire satisfaction of the EIC.

6. If the accepted bid value is 80% or less of the estimated put to tender, the additional Performance security @10% of the tendered Amount shall be submitted by the contractor in the form of Bank Guarantee from any schedule bank before issuance of the work order.
