 - Latest bank certificate (optional) as proof of the financial stability
 - Earnest money in the form of DD/Bank Draft from any Nationalized/scheduled Banks on Kolkata branches only in favour of **“KOLKATA METROPOLITAN DEVELOPMENT AUTHORITY”** to be submitted along with financial bid in a sealed cover.
2. Original documents may be verified by the tendering authority at its discretion.
 3. When the applicant is an authorized signatory, he should submit documents of authorization in his favour along with the application.
 4. Supply of all labour, tools & tackles, instruments, equipment, accessories, as are needed to complete the job, in a manner as specified to the entire satisfaction of the EIC.
 5. The contractor will be full responsible for safety and security of the labours, work men who will be Involved at this work. Also contractor will take care about surroundings areas and locality against any Incident or accident during such work.
 6. No mobilization advanced will be paid under any circumstances.
 7. If the accepted bid value is 80% or less of the estimated put to tender, the additional Performance security @10% of the tendered Amount shall be submitted by the contractor in the form of Bank Guarantee from any schedule bank before issuance of the work order.
 8.
