
The NIT application should include attested Photocopies of Pan all expenditure, GST & other taxes & duties as per norms, materials, labour, tools & plants, loading/unloading/carriage, testing charges or any seen and unseen expenditure to make the water supply network operational according to the schedule as per direction and satisfaction of the Engineer-In-Charge. The application should accompany, attested Photocopies of PAN card of the tenderer, Tax clearance challan, Income Tax return for last three years, GST registration Certificate, Affidavit, Credential/Completion Certificate of similar nature of work done in last 5(Five) years of not less than 50%(Fifty percent) of the quoted amount along with relevant work orders, Professional Tax Registration Certificate, duly signed and endorsed by the applicant with the words "**Submitted by me**". All the applicants will have to produce original documents of the above papers for verification at the time of opening of the tender, failing which tendered will be treated as cancelled. The successful tenderer will have to deposit Earnest money @ 2% of the estimate amount, in the shape of **Bank Draft/Pay Order** drawn in
