- (5) Completion certificate/Payment Certificate showing execution of similar nature of job value not less than 30% of the estimate amount put to tender.
- (6) Registration certificate and / or Trade License of the company.
- (7) Partnership deed (in case of partnership firm) with written power of attorney of signatory of the deed.
