Time will be reckoned as per server clock. b) The Financial Bid of the participant Quotationers will be opened only if the quotationer qualifies the Technical Bid evaluation. The decision of the Tender Inviting Authority will be final and binding to all concerned and no challenge against such decision will be entertained.
3. Intending Bidders should quote the rate excluding all Government, Statutory Taxes, GST and Labour Cess as applicable. The Tax invoice(s) need to be issued by the agency/supplier for raising claim under the contract showing separately, the tax charged in accordance with the provisions of GST Act, 2017.
