The authority making payment shall deduct such sum which together with the Earnest Money already deposited and converted into security deposit, shall amount to **10% of the value of works** executed at the material point of time and paid during the progressive running accounts bills, so that total deduction against Security deposit together with Earnest Money constitute **10% of the tendered value** of work actually done.

**The defect liability period** for this work shall be **One (1) year** from the date of completion of the work.
