- 5. Valid Electrical Contractor License.
- 6. Upto date Trade License Certificate.
- 7. S.C.C of Electrical Supervisor Containing Parts 1,2,11.
- 8. A written declaration on letter head as to correctness of all documents submitted and a declaration of penalty /debarment etc. faced by them. After scrutinizing all above documents department will issue quotation documents if those documents are found in order. In case of registered unemployed engineers' co-op societies necessary registration paper in support of theregistration shall be submitted.

# Mode of submission of quotation documents-

Documents shall be signed by the quotationer /authorized signatory with company's seal on each page of the documents.

Apart from the statutory Taxes, Cess etc. as per circular/notification of the Union Govt. / Govt. of W.B., Security Deposit @10% of billed value shall be deducted from contractor's bill of which EMD deposit Rs. 1050.00shall be converted into security deposit. The stated security deposit shall be refundable as per KMDA FROM No. 1.
