Issue of Tender Documents :

Intending tenderers have to apply in writing to the Executive Engineer, Division-O&M-IB, W&S Sector, and KMDA in their own letter headalong with photo copies of the following documents must be submitted duly signed with the noting **“SUBMITTING BY ME”** with paper seal in each documents within the stipulated date and time and also with NOTARY in original. **If required tenderers are bound to produce original certificates during verification of certificates of the copy.**

Photo copies of the following documents must be submitted :

- (1) Valid PAN Card.
- (2) Valid GST registration certificate.
- (3) UP to date Professional Tax Registration Certificate/Challan.
- (4) Completion certificate/Payment Certificate showing execution of **any civil** job value not Less than 40% of the estimate amount put to tender.
- (5) Registration certificate and/or Trade Licence of the company.
- (6) Partnership deed (in case of partnership firm) with written power of attorney of signatory of the deed.
- (7) Income Tax Return for last three financial year/assessment year, with Auditors report's & Balance Sheet.
- (8) A written declaration in the form of an Affidavit before Notary in non-judicial stamp paper as a correctness of the copies (each copy shall also to be certified by the Notary) of all documents submitted and a declaration of penalty/debarment etc. faced under any Govt/Semi Govt./Autonomous Body/institution etc.
- (9) Latest bank Solvency certificate as proof of the financial stability.
- (10) Earnest money in the form of DD/Bank Draft from any Nationalized/scheduled Banks on Kolkata branches only in favour of Kolkata Metropolitan Development Authority to be submitted along with financial bid in a sealed cover.

Note : Failure of submission of any one of the above mentioned documents will render the tender liable to summary rejection.

Terms &Condition :

1. When the applicant is an authorized signatory, he should submit documents of authorization in his favour along with the application.
2. Supply of all labour, tools & tackles, instruments, equipment, accessories, as are needed to complete the job, in a manner as specified to the entire satisfaction of the EIC.
3. The contractor will be full responsible for safety and security of the labours, work men who will be Involved at this work. Also contractor will take care about surroundings areas and locality against any Incident or accident during such work.
4. The Tender receipt by the Tendering authority from one other location will be opened at scheduled date and Time in presence of the intending tenderers.
5. No mobilization advanced will be paid under any circumstances.
6. If the accepted bid value is 80% or less of the estimated put to tender, the additional Performance security @10% of the tendered Amount shall be submitted by the contractor in the form of Bank Guarantee from any schedule bank before issuance of the work order.
7. Original documents may be verified by the tendering authority at its discretion.

8. Successful Tenderer have to execute an agreement with KMDA after finalization of tender in 05(Five) set of formal documents including KMDA Form No.1 for each works on payment in DD/Bank Draft for any Nationalized Bank on Kolkata branches only in favour of KMDA.
9. Intending tenderer have to submit the sealed bid in single part along with financial bid in one sealed cover is to be submitted in the Tender Box kept in the office of the Tendering Authority (Division-O&M-IB, Howrah).
10. Joint venture and consortium will not be accepted.
11. Joint venture and consortium will not be accepted.
12. The successful tenderer shall comply with provision of contract labour (regulation & Abolition) act, 1970 and the subsequent amendment thereof and produce the same before the authority.
13. Deduction of labour CESS @1% at source will be applicable under section-3 of the Building & other construction works welfare cess Act, 1996 read with rules 4 & 5 of the Building & other construction works welfare cess Rules, 1998 and GST.
