All the sectors and divisions must check from time to time in the BGRS portal the list of BGs which are on the verge of expiry and take appropriate steps accordingly.

B) Bank Guarantees issued by any agency is required to be verified by the issuing bank before taking further actions on it as per RBI guidelines. However, this Verification of Bank Guarantees in the manual mode takes considerable time.
