**Photo copies of the following documents must be submitted :**

- (1) Valid PAN Card.
- (2) Valid GST registration certificate.
- (3) UP to date Professional Tax Registration Certificate/Challan.
- (4) Completion certificate/Payment Certificate showing execution of similar nature of job value not Less than 40% of the estimate amount put to tender.
- (5) Registration certificate and/or Trade Licence of the company.
- (6) Partnership deed (in case of partnership firm) with written power of attorney of signatory of the deed.
- (7) Income Tax Return for last three financial year/assessment year, with Auditors report's & Balance Sheet.
- (8) A written declaration in the form of an Affidavit before Notary in non-judicial stamp paper as a correctness of the copies (each copy shall also be certified by the Notary) of all documents submitted and a declaration of penalty/debarment etc. faced under any Govt./Semi Govt./Autonomous Body/institution etc.
- (9) Latest bank Solvency certificate as proof of the financial stability.
- (10) Earnest money in the form of DD/Bank Draft from any Nationalized/scheduled Banks on Kolkata branches only in favour of Kolkata Metropolitan Development Authority to be submitted along with financial bid in a sealed cover.

**Note : Failure of submission of any one of the above mentioned documents will render the tender liable to summary rejection.**

2. Supply of all labour, tools & tackles, instruments, equipment, accessories, as are needed to complete the job, in a manner as specified to the entire satisfaction of the EIC.
3. The contractor will be full responsible for safety and security of the labours, work men who will be Involved at this work. Also contractor will take care about surroundings areas and locality against any Incident or accident during such work.
4. The Tender receipt by the Tendering authority from one other location will be opened at scheduled date and Time in presence of the intending tenderers.
5. No mobilization advanced will be paid under any circumstances.
6. If the accepted bid value is 80% or less of the estimated put to tender, the additional Performance security @10% of the tendered Amount shall be submitted by the contractor in the form of Bank Guarantee from any schedule bank before issuance of the work order.
7. Original documents may be verified by the tendering authority at its discretion.
