### Additional Terms & Condition in Tender Notice Clause-26 & SECTION-D\_SPECIAL PROVISION:

#### Compensation Clause as per latest verdict from the Hon'ble Supreme court:-

i)Bidder can pay compensation of rupees fifty 50,00,000/- (Rupees fifty lacs) in case any labour dies while working under the Contractor during any hazardous construction activity without proper safety rules. ii) While Climbing to staging height 10.0 mtr & above without safety measure should be made a crime even in emergency situation. For each such death of labour under the contractor, Compensation of Rs. 10.00 lakh should be paid by the Bidder to the family of the deceased.

- iii) Identify the families of all labours under the Contractor who have died in accidentally on construction field) since 1993 and award compensation of Rs 10 lakhs for each such death to the family members depending on them.
- iv) Rehabilitation must be based on the principles of justice and transformation.
