6. No mobilization advanced will be paid under any circumstances.
7. If the accepted bid value is **80% or less** of the estimated put to tender, the **additional Performance security @10% of the tendered Amount** shall be submitted by the contractor in the form of Bank Guarantee from any schedule bank before issuance of the work order.
