- 5. The contractor will be full responsible for safety and security of the labours, work men who will be Involved at this work. Also contractor will take care about surroundings areas and locality against any Incident or accident during such work.
- 6. No mobilization advanced will be paid under any circumstances.
- 7. If the accepted bid value is **80% or less** of the estimated put to tender, the **additional Performance security @10% of the tendered Amount** shall be submitted by the contractor in the form of Bank Guarantee from any schedule bank before issuance of the work order.
- 8.
