The documents in respect of I.T., P.T., GST, Trade License and Credential required to be produced at the time of submitting application. If the applicant is an authorized signatory, he should submit documents of authorization in his favour with the application. In case of partnership firm, copy of partnership deed is to be submitted along with the tender document. Un-employed Engineer's Co-operative society shall have to submit all document in respect of their society viz. Registration Certificate, Audit Balance Sheet for the last 3 (three) years.

In order to establish the Credentials, the tenderer submit certified copies of his earlier works of similar nature copies of receipts of payment by him. All the document stating "SUBMITTED BY ME" and duly signed. Tenderer should also give written declaration in the form of and "AFFIDAVIT" before Notary and to correctness of the copies of all the documents submitted and a declaration of penalty faced by him under any Govt. / Autonomous Body/ Institutions etc. if any the originals of all the submitted documents asked for submission for necessary verification by the tendering authority at its direction. Cess @ 1% of the value of works will be applicable as per RECS Act 1996 and Building and other construction worker's Welfare Cess Act 1996.

The tender (General Papers, Technical Bid and Earnest Money) is to be opened on the scheduled date and time as per NIT in presence of the intending tenderers or their authorized representatives who like to be present. Tenderers shall have to deposit earnest money of specified amount in the form of Bank Draft/ Pay Order of any nationalized bank in favour of K.M.D.A. conditional tender will not be considered for acceptance.

If the accepted bid value of the Successful Bidder is 80% or less of the estimated amount put to tender, Additional performance security @ 10% of the Tendered Amount shall be submitted in the form of Bank Guarantee as per latest Govt. order.
