Cess @ 1% of the value of works will be applicable as per RECS Act 1996 and Building and other construction worker's Welfare Cess Act 1996.

Tenderers shall have to deposit earnest money of specified amount in the form of **Bank Draft /Demand Draft/ Pay Order** of any nationalized/ Scheduled Bank in favour of **K.M.D.A.** payable at Kolkata.

The authority making payment shall deduct such sum which together with the Earnest Money already deposited and converted into security deposit, shall amount to **10% of the value of works** executed at the material point of time and paid during the progressive running accounts bills, so that total deduction against Security deposit together with Earnest Money constitute **10% of the tendered value** of work actually done.

**The defect liability period** for this work shall be One **(1) Year** from the date of completion of the work.

Conditional tender will not be considered for acceptance. The authority reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever.
