6. Eligibility criteria for the bidders :-

a) Technical:-

- i. Intending tenderers should produce credentials of a similar nature (as mentioned above Sl. No. 1) of completed work of the minimum value of Rs. 2.61 Croresput to tender during 5(five) years prior to the date of issue of the tender notice; or
- ii. Intending tenderers should produce credentials of 2(two) similar nature (as mentioned above Sl. No. 1) of completed work, each of the minimum value of Rs. 2.18 Croresput to tender during 5(five) years prior to the date of issue of the tender notice; or,
- iii. Intending tenderers should produce credentials of one single running work of similar nature (as mentioned above Sl. No. 1) which has been completed to the extent of 75% or more and value of which is not less than the desired value at 6.a.(i) above;
In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and-also that no penal action has been initiated against the executing agency, i.e., the tenderer.

b) Financial:-

- i. The bidder should have minimum average annual turnover of Rs.2.18 Crores during last 3 (three) years ending on 31.03.2025.
 - ii. Bank Solvency Certificate as per Annexure-III, minimum value of Rs.0.9 (Zero point nine) Crores or above and date of which shall not be more than 6 (six) months before the publication date of the e-NIT.
- c)** Scanned copy of Valid PAN issued by the IT Deptt. , Govt of India, Latest Professional Tax Paid Challan & P-TAX Enrollment Certificate, Valid income tax (For Last 3 yrs), Valid 15 digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017, Last 3 yrs Audit balance sheet , Credentials (Work Order, & Completion Certificate of the same work as per Sl-1 & 6,(a) of this NIT), Employees PF and ESI , Bank Solvency Certificate as Sl-6,b(ii), Valid trade license of the company must be submitted duly digitally signed at desired location in the website <https://wbtenders.gov.in>.
- d)** The following clause shall be included in all the contracts to be executed for (i) procurement of goods and services and (b) works related contract involving supply of goods and services by contractor: "Tax invoice (s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act ,2017."
- e)** Scanned Copy of one affidavit before Notary will have to be submitted mentioning the correctness of the documents and a declaration of penalty debarment etc. faced by him under any Govt./Semi-Govt./Govt. - f)** Partnership Firm/Consortium should submit necessary deed at desired location through on line.
- h) Earnest Money:** -The tenderer shall have to deposit Earnest Money through online, as mentioned in the e-NIT, failing which the tender shall be rejected. The balance earnest money if any to fulfill 2 (two) percent of the tender value is to be deposited by the successful bidder in the form of BG at the time of execution of formal agreement in accordance with the Finance Department Order No.-5696-F(Y), dated.-01/10/2019.

8. **Language of Tender: -** The tender shall be submitted in the prescribed form in English. All literatures and correspondence in connection with the tenders shall be in English.
9. **Provision of Defect Liability Period & Refund of Security Deposit:** Bidders shall have to execute the work in such a manner so that appropriate service level for the stipulated work is to be maintained during stipulated contractual period till actual date of completion and a Defect Liability Period for the work is 05(Five) years from the date of actual successful completion of the work. If any defect/ damage is found during the period as mentioned above, the contractor shall make good the same at his own expense to the specification at par with instant project work, or in default, the Engineer-in-charge may cause the same to be made good by other agency and deduct the expense (for which the certificate of the Engineer-in-charge shall be final) from any sums that may be then, or at any time thereafter become due to contractor, or from his security deposit, or the proceeds of the sale thereof, or of sufficient portion thereof or from any pending dues for any contract with KMDA. For five years defect liability period, 30% of the Total Security deposit shall be refunded to the contractor on expiry of four years from the actual date of completion of the work and the balance 70% of the Security deposit shall be refunded to the contractor on expiry of five years from the actual date of completion of the work.
10. **Security Deposit:** The SD money will be deducted from the successive bills of the eligible agency @8% of the bill value and to be retained by the Department till DLP is over. During release of the SD money, total 10% of the contract/tendered value will be released including 2% of the EMD deposited initially
- 11) **Others: -** The Tender Notice along with other documents like **Tender Form No. -1 KMDA, Technical Specification, Special Terms and Conditions, BOQ, Addendums and corrigendum's etc.** whatever documents uploaded by the department concerned thereto shall be part and parcel of the Tender. The agency must go through carefully the Special Terms and Conditions uploaded by the department before quoting his rate. **All the bidders are requested to upload only necessary documents for the tender. Uploading unnecessary/irrelevant documents may create problem in the evaluation process.
