**6) Eligibility criteria for the bidders :-**

**a) Technical:-**

- i. Intending tenderers should produce credentials of similar nature (as mentioned above in Sl. No. 1, of completed work in Single contract of the minimum value of Rs. 0.44 Crore during 5(Five) years prior to the date of issue of the tender notice; or Intending tenderers should produce credentials of 2(two) no's of similar nature as mentioned above Sl. No. 1, of completed work in Single Tender of the minimum value of Rs. 0.33 Crore during 5(Five) years prior to the date of issue of the tender notice; or,
- ii. Intending tenderers should produce credentials of one single running work of similar nature (as mentioned above Sl. No. 1,a.) which has been completed to the extent of **80%** or more and value of which is not less than the desired value at (i)above; In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, Or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that nopenal action has been initiated against the executing agency, i.e., the tenderer.

**b) Financial:-**

- i. The bidder should have minimum average annual turnover of RS. **0.33**(Zero Point Three Three) Crores during three consecutive financial year within last 5 (five) years ending on 31.03.2023. **8) Time of completion:** Time of completion shall be **04** (Four months) including from the date of commencement of the project.

**9) Provision of Defect Liability Period & Refund of Security Deposit :** Prospective bidders shall have to execute the work in such a manner so that appropriate service level for the stipulated work is to be maintained during stipulated contractual period till completion and **Defect Liability Period for 05(five) years** and its start from the date of successful completion of the work. If any defect/ damage is found during the period as mentioned above, the contractor shall make good the same at his own expense to the specification at par with instant project work, or in default, the Engineer-in-charge may cause the same to be made good by other agency and deduct the expense (for which the certificate of the Engineer-in-charge shall be final) from any sums that may be then, or at any time thereafter become due to contractor, or from his security deposit, or the proceeds of the sale thereof, or of sufficient portion thereof or from any pending dues for any contract with KMDA . Refund of Security Deposit will only be made after completion of **Defect Liability Period (DLP)**.

**10) Language of Tender:-** The tender shall be submitted in the prescribed form in English. All literatures and correspondence in connection with the tenders shall be in English. All illiterate documents shall be uploaded in English language only.

**11) Others :-** The Tender Notice along with other documents like **Tender Form No. - 1 KMDA, Technical Specification, Special Terms and Conditions , BOQ, Addendums and corrigendum's etc.** whatever documents uploaded by the department concerned thereto shall be part and parcel of the Tender. The agency must go through carefully the Special Terms and
