6) Eligibility criteria for the bidders :-

a) Technical:-

- i. Intending tenderers should produce credentials of similar nature (as mentioned above in Sl. No. 1, of completed work in Single contract of the minimum value of Rs. **1.90** Crore put to tender during 5(Five) years prior to the date of issue of the tender notice; or Intending tenderers should produce credentials of 2(two) no's of similar nature (as mentioned above Sl. No. 1, of completed work in Single Tender of the minimum value of Rs. **1.43** Crore put to tender during 5(Five) years prior to the date of issue of the tender notice; or,
- ii. Intending tenderers should produce credentials of one single running work of similar nature (as mentioned above Sl. No. 1,a.) which has been completed to the extent of **80%** or more and value of which is not less than the desired value at (i) above; In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, Or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and-also that no penal action has been initiated against the executing agency, i.e., the tenderer.

b) Financial :-

- i. The bidder should have minimum average annual turnover of RS. **1.43** (one point four three) Crore during three consecutive financial year within last 5 (five) years ending on 31.03.2024. (Relevant documents shall be uploaded by the bidder through Tender Portal (www.wbtenders.gov.in) for checking the eligibility)
 - ii. Bank Solvency Certificate as per prescribed format (Annexure-III) minimum value of Rs. **0.50** (Zero point five) Crore or above and date of which shall not be more than 6 (six) months before the date of issue of the e-NIT.)
- c)** Scanned copy of original documents i.e. Valid PAN issued by the IT Deptt., Govt. of India, Latest Professional Tax Paid Challan as per enrollment rate slab & P- TAX Enrollment Certificate, Valid income tax (For Last 3 yrs), Valid 15 digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017, Last 3 yrs Audit balance sheet , Credentials (LOI/Work Order, & Completion Certificate of the same work as per Sl-1 & 6,(a) of this NIT), Employees PF and ESI , Bank Solvency Certificate as per Sl-6,b(ii), Valid trade license of the company must be submitted duly digitally signed at desired location in the website <https://wbtenders.gov.in>.
- d)** The following clause shall be included in all the contracts to be executed for (i) procurement of goods and services and (b) works related contract involving supply of goods and services by contractor: "Tax invoice (s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act ,2017."
- e)** Scanned Copy of one original affidavit before Notary will have to be submitted mentioning the correctness of the documents and a declaration of penalty debarment etc. faced by him under any Govt./Semi-Govt./Govt. Undertaking /Autonomous body (constituted under the

State/Central statute)/ Statutory Bodies and Local Bodies, submitted through online at desired location (as per Annexure-I) and declaration by the tenderer as per prescribed format (Annexure-II).

f) Partnership Firm/Consortium should submit necessary deed at desired location through on line.

g) **Earnest Money:** - The initial Earnest Money shall be of **Rs. 9, 51, 359/-** (Rupees nine lakhs fifty-one thousand three hundred fifty-nine) only, shall be deposited through online as per the system in the tender portal i.e (www.wbtenders.gov.in) in the respective field, failing which the tender shall be rejected. The successful tenderer shall have to submit an additional amount against Earnest Money @ 2% of the awarded tender value if that exceed already deposited EMD the balance amount will be deposited in the form of Demand Draft drawn in favour of “Housing Sector KMDA” of a scheduled Indian Bank on Kolkata.

h) **Security Deposit:** - Along with the initial Earnest Money (2% of quoted amount) an additional amount of 8% (eight percent) will be deduct from the each and every running bill in the form of **SECURITY DEPOSIT** to meet up 10% and it shall be released as per prevailing tender norms.

8) **Time of completion:** Time of completion shall be **09** (Nine months) including from the date of commencement of the project.

9) **Provision of Defect Liability Period & Refund of Security Deposit :** Prospective bidders shall have to execute the work in such a manner so that appropriate service level for the stipulated work is to be maintained during stipulated contractual period till actual date of completion and a Defect Liability Period for the work is 05(Five) years from the date of actual successful completion of the work. If any defect/ damage is found during the period as mentioned above, the contractor shall make good the same at his own expense to the specification at par with instant project work, or in default, the Engineer-in-charge may cause the same to be made good by other agency and deduct the expense (for which the certificate of the Engineer-in-charge shall be final) from any sums that may be then, or at any time thereafter become due to contractor, or from his security deposit, or the proceeds of the sale thereof, or of sufficient portion thereof or from any pending dues for any contract with KMDA . For five years defect liability period, 30% of the Total Security deposit shall be refunded to the contractor on expiry of four years from the actual date of completion of the work and the balance 70% of the Security deposit shall be refunded to the contractor on expiry of five years from the actual date of completion of the work.

- 10) **Language of Tender:** - The tender shall be submitted in the prescribed form in English. All literatures and correspondence in connection with the tenders shall be in English. All illiterate documents shall be uploaded in English language only.
- 11) **Others:-** The Tender Notice along with other documents like **Tender Form No. - 1 KMDA, Technical Specification, Special Terms and Conditions , BOQ, Addendums and corrigendum's etc.** whatever documents uploaded by the department concerned thereto shall be part and parcel of the Tender. The agency must go through carefully the Special Terms and Conditions uploaded by the department before quoting his rate. **All the bidders are requested to upload only necessary documents for the tender. Uploading unnecessary/irrelevant documents may create problem in the evaluation process.
