6. Eligibility criteria for the bidders :-

a) Technical:-

- i. Intending tenderers should produce credentials of a similar nature (as mentioned above Sl. No. 1) of completed work in a single tender for the minimum value of Rs. **0.34Crore** during 5(five) years prior to the date of issue of the tender notice; or or,
- ii. Intending tenderers should produce credentials of one single running work of similar nature (as mentioned above Sl. No. 1) which has been completed to the extent of **70%** or more and value of which is not less than the desired value at 6.a.(i) above; In case of JV credential for running work will not be consider. In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, Or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and-also that no penal action has been initiated against the executing agency, i.e., the tenderer.

b) Financial:-

- i. The bidder should have minimum average annual turnover of Rs. 0.43Crore (Forty three lakhs) during three consecutive financial year within last 5 (five) years ending on **31.03.2022**. (Relevant documents shall be uploaded by the bidder through Tender Portal(www.wbtenders.gov.in) for checking the eligibility).

8. **Time of completion:** Time of completion shall be 12(Twelve months) including 03(Three) months Trial Run from the date of commencement of the project, after completion of 03(Three) months Trial Run 01(One) year O&M shall be started.
9. The Earnest Money as mentioned in the NIT shall deposited through online. EMD for successful bidder shall be converted to part initial security deposit and the balance amount as security deposit for this tender will be deducted @ 1% (one percent) of the gross bill value of each and every running bill and in the final bill an adjustment in percentage security deduction will be made so that the total security will be @3 % of the final gross bill value.
10. **Provision of Defect Liability Period & Refund of Security Deposit :**
Prospective bidders shall have to execute the work in such a manner so that appropriate service level for the stipulated work is to be maintained during stipulated contractual period till actual date of completion and a Defect Liability Period for the work is **05(Five) years from the date of actual successful completion of the work.** If any defect/ damage is found during the period as mentioned above, the contractor shall make good the same at his own expense to the specification at par with instant project work, or in default, the Engineer-in-charge may cause the same to be made good by other agency and deduct the expense (for which the certificate of the Engineer-in-charge shall be final) from any sums that may be then, or at any time thereafter become due to contractor, or from his security deposit, or the proceeds of the sale thereof, or of sufficient portion thereof or from any pending dues for any contract with KMDA . For five years defect liability period, 30% of the Total Security deposit shall be refunded to the contractor on expiry of four years from the actual date of completion of the work and the balance 70% of the Security deposit shall be refunded to the contractor on expiry of five years from the actual date of completion of the work.
11. **Bid validity period:-**Bids shall remain valid for a period not less than 180 (One hundred eighty) days after the dead line date for Financial Bid/Sealed Bid submission. Bid valid for a shorter period shall be rejected by the TIA as non-responsive. If the bidder withdraws the bid during the period of bid validity the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.
12. **Bid Opening:-**Bids received shall be opened online at the specified date and time given in nit .If the office is closed on the specified date of opening of the bids, the opening shall be done on the next working day at the same time.
13. **Language of Tender:-** The tender shall be submitted in the prescribed form in English. All literatures and correspondence in connection with the tenders shall be in English.
