- i) The prospective bidders shall have satisfactorily completed as a prime agency during the last 5(five) years prior to the date of issue of this Notice at least one work of similar nature i.e. **Operation and Maintenance of STP/WTP/ETP with Disinfection unit for at least One year** under the authority of State / Central Gov., State/Central Gov. undertaking /Statutory Bodies constituted under the statute of the Central / State Government and having a magnitude of not less than **Rs. 26.86 Lakh**,

**In case of running works**, only those quotationer /bidders who will submit the **current certificate of satisfactory running work from the concerned Executive Engineer**, or equivalent competent authority will be eligible for the quotation. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executing agency, i.e. the quotationers/bidders.

b) **Financial:-**

Intending tenderers (firms / companies / individual contractors) should produce minimum average annual turnover of **Rs. 26.86 Lakh** for last 3 (Three) Financial Years.

B) **Other terms and condition of the credentials:**

- i) Payment certificate will not be treated as credential.
- ii) **Completion Certificate** issued by the Executive Engineer or equivalent competent authority of a State/Central Govt., State/Central Govt. undertaking, Statutory/Autonomous bodies constituted under the Central/State Statute on the executed value of completed/running works will be considered as Credential.
- iii) No credential will be considered as valid unless it is supported by Work Order, price schedule or BOQ of work and completion certificate mentioning the date of completion issued by the competent authority not below the rank of Executive Engineer or equivalent or competent authority of a State / Central Government, State / Central Government undertakings, Statutory / Autonomous bodies constituted under the Central / State Statute. - B) Scanned copy of PAN card issued by the IT Deptt., Govt. of India, Latest Professional Tax Paid Challan as per Enrollment Rate Slab, Valid income tax return (for Last 3 yrs i.e. year ending 2022), Valid 15 digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017 & Latest Valid Trade License, Last 3 yrs audited balance sheet ,Credentials (Work Order & Completion Certificate of the same work), Bank Solvency Certificate of **minimum Rs. 13.43 Lakh** within 1 (one) year prior to the date of publishing of NIT, valid Provident Fund & ESI Registration Certificate Registration Certificate and/or trade license of the company must be submitted duly digitally signed at desired location in the website <https://wbtenders.gov.in>.

E) **Earnest Money and Security Deposit:** - The initial Earnest Money shall be deposited through online as per the system in the tender portal i.e. (www.wbtenders.gov.in) in the respective field, failing which the tender shall be rejected. The successful tenderer shall have to submit balance amount against Earnest Money @ 2% of the awarded tender value, if that exceeds already deposited EMD value. Balance Security Deposit amounting to @ 8% of the work value shall be deducted from the each and every R/A Bill as per prevailing order (subject to implementation of latest Govt. Order in this respect). No interest will be paid on the Security Deposit.

- 5) Time of completion: Time of completion shall be **4 (Four)** months followed by O & M of 5 (Five Years) shall be reckoned from the date of completion of the project.
- 6) The prospective bidders shall have in their full time engagement experienced technical personnel, with the sufficient knowledge of PERT/CPM, the minimum being One Civil Engineering Degree holder and One Civil Engineering Diploma holder.
- 7) Neither prospective bidders nor any of constituent partner had been debarred to participate in tender by the KMDA during the last 5 (five) years prior to the date of this NIQ. Such debar will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders as per prescribed format without which the Technical Bid shall be treated non-responsive).
- 8) All materials required for execution of the work (as per BOQ) shall be supplied by the contractor at their own cost. The following clause shall be included in all the contracts to be executed for (i) procurement of goods and services and (b) works related contract involving supply of goods and services by contractor: "Tax invoice (s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act,2017."
- 9) **Bids shall remain valid** for a period not less than **120 days** (One Hundred Twenty) from the last date of submission of Financial Bid / Sealed Bid. If the bidder withdraws the bid during the period of bid validity the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.
- 10) **CONDITIONAL and INCOMPLETE TENDER** will not be accepted under any circumstances.
- 11) The **Superintending Engineer, North Circle, GAP Wing, Water & Sanitation Sector, KMDA** reserves the right to cancel the N.I.Q. due to unavoidable circumstances and no claim in this respect will be entertained.
- 12) During scrutiny, if it is come to the notice to quotation inviting authority that the credential or any other papers found incorrect/manufactured/fabricated, that quotationer will not be allowed to participate in the quotation and that application will be out rightly rejected without any prejudice with forfeiture of earnest money forthwith.

List of "Technically Qualified Bidders" will be published in the web portal only. Financial Bid will be opened within a short period after such publication. Therefore Bidders are requested to view the tender status on a regular basis. In case if there be any objection regarding Pre- qualification/ list of " Technically Qualified Bidders", that objection should be lodged to the Chairman, Quotation/Bid Evaluation Committee within **24 hours** from the date and time of publication of list of qualified Agency and beyond that time schedule no objection will be entertained by the Quotation/Bid Evaluation Committee.

- 13) Before issuance of the LOI, the tender inviting authority may verify the credential & other documents of the lowest quotationer if found necessary. After verification, if it is found that such documents submitted by the lowest quotationer is either manufacture or false in that case, LOI will not be issued in favour of the quotationer under any circumstances. In that case Bidder's Earnest Money/ Bid Security shall be forfeited.

14) **Language of Tender:-** The tender shall be submitted in the prescribed form in English. All literatures and correspondence in connection with the quotations shall be in English.

15) **Others:-** The Quotation Notice along with other documents like **Tender Form No. - 1 KMDA, Technical Specification, Special Terms and Conditions, General Terms and Conditions, BOQ, Addendums and corrigendum's etc.** whatever documents uploaded by the department concerned thereto shall be part and parcel of the Quotation. The agency must go through carefully the Special Terms and Conditions uploaded by the department before quoting his rate. **All the bidders are requested to upload only necessary documents for the quotation. Uploading unnecessary / irrelevant documents may create problem in the evaluation process. In that case any inadvertent mistake during evaluation of the tender, Quotation Inviting Authority (QIA) will not be responsible.**

16) **Provision of Defect Liability Period & Refund of Security Deposit :**

Prospective bidders shall have to execute the work in such a manner so that appropriate service level for the stipulated work is to be maintained during stipulated contractual period till actual date of completion and a Defect Liability Period for the work is 05(Five) years from the date of actual successful construction-completion of the work. If any defect/ damage is found during the period as mentioned above, the contractor shall make good the same at his own expense to the specification at par with instant project work, or in default, the Engineer-in-charge may cause the same to be made good by other agency and deduct the expense (for which the certificate of the Engineer-in-charge shall be final) from any sums that may be then, or at any time thereafter become due to contractor, or from his security deposit, or the proceeds of the sale thereof, or of sufficient portion thereof or from any pending dues for any contract with KMDA. The Security Deposit shall be refunded to the agency in the following manner:

- (i) On completion of Four year of O&M: 30% of the deducted S.D.
- (ii) On completion of Five year of O&M: Full balance S.D.

17) **Suspension and Debarment:-**

Procedure for Suspension and Debarment of Contractors/bidder / Agency/Consultants will be as per order no(PWD, Govt. of WB) 547-W(C )/1M-387/15,dated16.11.2015 and 724-W(C)/1M-953/19,dated 19.12.2013. Technical Bid shall be treated as nonresponsive if anything adverse has come to the notice of the tender inviting authority against the Firm/Agency/ bidder so far as his performance within the jurisdiction of the concerned circle. The prospective bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility.

18) **Language of Tender:-** The tender shall be submitted in the prescribed form in English. All literatures and correspondence in connection with the tenders shall be in English.

19) **Validity of Tender:** Tender once submitted shall remain valid for a period **120 (one hundred twenty) days** from the date of receiving tender. Any extension of such validity period will be subjected to the concurrence of the tenderer.

20) **Price Adjustment, Escalation, Mobilization Advance & Secured Advance and Price Preference:-**

Price Adjustment (Increase or decrease of price) over any kind of materials, labour, fuel &

lubricants etc will not be applicable for the work/works of this NIT/NIQ. Similarly, Escalation over any kind of materials, labour, fuel & lubricants etc and Mobilization Advance will not be applicable for the work/works.

21) **Others:** - The Tender Notice along with other documents like **Tender Form No. - 1 KMDA, Technical Specification, Special Terms and Conditions , BOQ, Addendums and corrigendum's etc.** whatever documents uploaded by the department concerned thereto shall be part and parcel of the Tender. The agency must go through carefully the Special Terms and Conditions uploaded by the department before quoting his rate. **All the bidders are requested to upload only necessary documents for the tender. Uploading unnecessary/irrelevant documents may create problem in the evaluation process. In that case any inadvertent mistake during evaluation of the tender, Tender Inviting Authority (TIA) will not be responsible.**

22) **Penalty for suppression / distortion of facts:** If any document/statement/information submitted by any bidder in the tender is found to be false, the Tender Inviting Authority (TIA) will take legal action against the bidder including forfeiture of Earnest Money Deposit (EMD)."

23) **Blacklisting / Poor Performance / Termination :** The bidder should not be blacklisted or debarred in last 5 years from any Central or State Government/Semi-government / PSUs / PHED / Water Boards / Water Utility departments. The bidder should not be penalized or terminated for their poor performance in the last 5 years from any Central or State Government/Semi-government / PSUs / PHED / Water Boards / Water Utility departments. Such suspension / debarment / termination, unless the same has been revoked, will be considered as disqualification towards eligibility..

- The contractor who have been delisted or debarred by any Government Department shall not be eligible in any way. Besides, the prospective Bidder or any of their constituent

partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will also be considered as disqualification towards eligibility. **[An undertaking should be given stating thereby that the Firm has not been debarred or penalized for any reasons out of work by any Government Department, in Non – Judicial Stamp paper of appropriate value duly notarized as per Proforma given in Annexure\_, in absence of which the bid will be liable for rejection. [Non statutory Documents]**

24) **Insolvency / Bankruptcy Code:** The applicant **should not be currently under any Insolvency Bankruptcy Code (IBC) resolution process at National Company Law Tribunal (NCTL).**

The tender inviting authority (TIA) reserves the right to accept or reject any or all the tenders without assigning any reason what so ever.

**While evaluation, the committee may summon of the tenderers & seek clarification/ information or additional documents or original in hard copy/soft copy, if any shortfall documents may require by the TIA it shall only be uploaded in Tender portal ([www.wbtenders.gov.in](http://www.wbtenders.gov.in)) within the stipulated time period.**

**Any of the documents already submitted & if they are not produced within the stipulated time frame, their bid will liable for rejection.**

**25) List of "Technically Qualified Bidders" will be published in the web portal only. The Financial Bid of the prospective Tenderers will be opened only if the tenderer qualifies in the Technical Bid. In case if there be any objection regarding Pre-qualification/ list of "Technically Qualified Bidders", that objection should be lodged to the Tender Inviting Authority within **48 hours** from the date and time of publication of list of qualified Agency and beyond that time schedule no objection will be entertained by the Tender Inviting Authority. The decision of the Tender Inviting Authority will be final and binding to all concerned and no challenge against such decision will be entertained.**

**26) There shall be no provision of Arbitration. All the disputes arising from the provisions of the said agreement come under the jurisdiction of Calcutta High Court or any other competent court as the case may be.**

**27) If the L1 bidder does not agree to execute the job after opening of Bid, the Earnest Money will be forfeited without any further intimation and may be construed as an attempt to disturb the tendering process and dealt with accordingly legally including debarment up to 3(three) years of the Bidder.**

**28) Suspension and Debarment of Bidders, Contractors and Consultants during competitive bidding and contract implementation:**

The procedure as laid down below shall govern the suspension/debarment of Bidders/Contractors/Consultants (Contractors for brevity) involved in Government procurement for offences or violations committed during competitive bidding and contract implementation, for the works under different Departments of Government of West Bengal: -  
Grounds for Suspension and Debarment: -

- (1) Submission of eligibility requirements containing false information or falsified documents.
- (2) Submission of Bids that contain false information or falsified documents, or the concealment of such information in the Bids in order to influence the outcome of eligibility screening or any other stage of the bidding process.
- (3) Unauthorized use of one's name/digital signature certificate for the purpose of bidding process.
- (4) Any documented unsolicited attempt by a bidder (A Person/Contractor/Agency /Joint Venture/Consortium/Corporation participating in the procurement process and/or a person / Contractor / Agency / Joint Venture / Consortium / Corporation having an agreement/contract for any procurement with the department shall be referred as Bidder) unduly influencing the outcome of the bidding in his favour.
- (5) Refusal or failure to post a self-declaration to the effect of any previous debarment imposed by any other department of State Government and/or Central Government. (6) All other acts that tend to defeat the purpose of the competitive bidding such as lodging false complain about any Bidder, lodging false complain about any Officer duly authorized by the Department, restraining any interested bidder to participate in the bidding process, etc.
- (7) Assignment and subcontracting of the contract or any part thereof without prior written approval of the procuring entity.
- (8) Whenever adverse reports related to adverse performance, misbehavior, direct or indirect involvement in threatening, making false complaints etc. damaging the reputation of the department or any other type complaint considered fit by the competent authority of the department, are received from more than one Officer or on more than one occasion from individual Officer.
- (9) Refusal or failure to post the required performance security / earnest money within the

prescribed time without justifiable cause. (10) Refusal to accept an award after issuance of "Letter of Acceptance" or enter into contract with the Government without justifiable cause.

(11) Failure of the Contractor, due solely to his fault or negligence, to mobilize and start work or performance within the specified period as mentioned in the "Letter of Acceptance", "Letter of Acceptance cum Work Order", "Work Order", "Notice to Proceed", "Award of Contract", etc.

(12) Failure by the Contractor to fully and faithfully comply with its contractual obligations without valid cause, or failure by the Contractor to comply with any written lawful instruction of the Procuring Entity/Authority (the Officer authorized by the KMDA for procurement and execution) or its representative(s) pursuant to the implementation of the Contract.

(13) For the procurement of Consultancy Service/Contracts, poor performance by the Consultant of his services arising from his fault or negligence. Any of the following acts by the Consultant shall be construed as poor performance. (i) Non-deployment of competent technical personnel, competent Engineers and/or work supervisors; (ii) Non-deployment of committed equipment, facilities, support staff and manpower; (iii) Defective design resulting in substantial corrective works in design and/or construction; (iv) Failure to deliver critical outputs due to consultant's fault or negligence; (v) Specifying materials which are inappropriate and substandard or way above acceptable standards leading to high procurement cost; (vi) Allowing defective workmanship or works by the Contractor being supervised by the Consultant.

(14) For the procurement of goods, unsatisfactory progress in the delivery of the goods by the manufacturer, supplier, or distributor arising from his fault or negligence and/or unsatisfactory or inferior quality of goods, vis-à-vis as laid down in the contract.

(15) Willful or deliberate abandonment or non-performance of the project or Contract by the Contractor resulting in substantial breach thereof without lawful and/or just cause.

**CATEGORY OF OFFENCE: -**

(A) First degree of offence: 1 to 15 of the above Article to be considered as First degree of offence.

(B) Second degree of offence: Any one of the offences as mentioned under 'A' above, committed by a particular Bidder/Contractor/Supplier on more than one occasion, be considered as Second degree of offence.


**In addition to the penalty of suspension/debarment, the bid security / earnest money posted by the concerned Bidder or prospective Bidder shall also be forfeited.**

**PENALTY FOR OFFENCE :-**

(I) For committing First degree of offence: Disqualifying a Bidder from participating in any procurement process under the Administrative Department of Government of West Bengal up to 2 (two) years.

(II) For committing Second degree of offence: Disqualifying a Bidder from participating in any procurement process under the Administrative Department of Government of West Bengal up to 3 (three) years.


