The prospective bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility.

- Identification (latitude & longitude) of all secondary drains/storm water drain/sewage) falling into main canal from downstream to upstream. Measuring the flow in MLD of each outfall (11 nos.)-(minimum 12 hours continuous flow measurement with 30 minutes intervals) for 4 days (3 working day and 1weekend) as per CPHEEO approved method. For outfalls where flow is negligible only latitude & longitude of the junction points of the primary drain is to be measured (No additional payment will be done for this type of outfall).
