4) Eligibility criteria for the bidders :-

A) *The bidders should have the credentials as detailed below:*

a) *Technical:-*

- i) The prospective bidders shall have satisfactorily completed as a prime agency during the last 5(five) years prior to the date of issue of this Notice at least one work of similar nature i.e. Construction/Renovation/Rejuvenation of STP or any Embankment Protection work under the authority of State / Central Gov., State/Central Gov. undertaking /Statutory Bodies constituted under the statute of the Central / State Government and having a magnitude of not less than **Rs. 22.83 Lakh**,
- or
- ii) Intending quotationers /bidders should produce credentials of 2(two) similar nature of completed work i.e. Construction/Renovation/Rejuvenation of STP or any Embankment Protection work under the authority of State / Central Gov., State/Central Gov. undertaking /Statutory Bodies constituted under the statute of the Central / State Government and having a magnitude of not less than minimum value of **Rs. 19.02 Lakh** for each of the two work during 5(five) years prior to the date of issue of the tender notice,
- or
- iii) Intending quotationers / bidders should produce credentials of one single running work of similar nature i.e. . Construction/Renovation/Rejuvenation of STP or any Embankment Protection work under the authority of State / Central Gov., State/Central Gov. undertaking /Statutory Bodies constituted under the statute of the Central / State Government, which has been completed to the extent of 75% or more and value of which is not less than the desired value at (i) above.

Running O&M works shall not be treated as Running Work as mentioned in (iii) above and those will be treated as completed works subject to certification of the same by the concerned Executive Engineer or equivalent competent authority.

In case of running works, only those quotationers /bidders who will submit the current certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the quotation/tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executing agency, i.e. the quotationers/bidders.

b) *Financial:-*

Intending tenderers (firms / companies / individual contractors) should produce minimum average annual turnover of **Rs. 15.22 Lakh** for last 3 (Three) Financial Years.

B) *Other terms and condition of the credentials:*

- i) Payment certificate will not be treated as credential.
- ii) **Completion Certificate** issued by the Executive Engineer or equivalent competent authority of a State/Central Govt., State/Central Govt. undertaking,

Statutory/Autonomous bodies constituted under the Central/State Statute on the executed value of completed/running works will be considered as Credential.

- iii) No credential will be considered as valid unless it is supported by Work Order, price schedule or BOQ of work and completion certificate mentioning the date of completion issued by the competent authority not below the rank of Executive Engineer or equivalent or competent authority of a State / Central Government, State / Central Government undertakings, Statutory / Autonomous bodies constituted under the Central / State Statute. The completion certificate should indicate the value of the work (equal to booked expenditure) [Non Statutory Documents].

N.B. Estimated amount, Date of completion of project & detail communicational address of Client must be indicated in the Credential Certificate.

- B) Scanned copy of PAN card issued by the IT Deptt., Govt. of India, Latest Professional Tax Paid Challan as per Enrollment Rate Slab, Valid income tax return (for Last 3 yrs i.e. year ending 2023), Valid 15 digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017 & Latest Valid Trade License, Last 3 yrs audited balance sheet i.e. year ending 2023, Credentials (Work Order & Completion Certificate of the same work), Bank Solvency Certificate of minimum Rs. 15 Lakh within 1 (one) year prior to the date of publishing of NIT, valid Provident Fund & ESI Registration Certificate Registration Certificate and/or trade license of the company must be submitted duly digitally signed at desired location in the website <https://wbtenders.gov.in>.
- C) The following clause shall be included in all the contracts to be executed for (i) procurement of goods and services and (b) works related contract involving supply of goods and services by contractor: "Tax invoice (s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017."
- D) Scanned Copy of one affidavit before Notary will have to be submitted mentioning the correctness of the documents and a declaration of penalty debarment etc. faced by him under any Govt./Semi-Govt./Govt. Undertaking /Autonomous body (constituted under the State/Central statute)/ Statutory Bodies and Local Bodies, submitted through online at desired location (as per Annexure-I) and declaration by the tenderer as per prescribed format (Annexure-I).
- E) **Earnest Money and Security Deposit:** - The Earnest Money shall be of **Rs. 1,52,169/- (Rupees One Lakh Fifty-Two Thousand One Hundred Sixty Nine Only)**, shall be deposited through online as per the system in the tender portal i.e. (www.wbtenders.gov.in) in the respective field, failing which the tender shall be rejected. Earnest Money @ 2% of the Tended Value would be converted to initial Security Deposit in case of the successful bidder. Balance Security Deposit amounting to @ 8% of the work value shall be deducted from the R/A Bills as per prevailing order (subject to implementation of latest Govt. Order in this respect). No interest will be paid on Security Deposit.

6) Time of completion: Time of completion shall be 3(Three) months.

7) The prospective bidders shall have in their full time engagement experienced technical personnel, with the sufficient knowledge of PERT/CPM, the minimum being One Civil Engineering Degree holder and One Civil Engineering Diploma holder.

8) Neither prospective bidders nor any of constituent partner had been debarred to participate in tender by the KMDA during the last 5 (five) years prior to the date of this NIT. Such debarment will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders as per prescribed format without which the Technical Bid shall be treated non-responsive).

- 9) All materials required for execution of the work (as per BOQ) shall be supplied by the contractor at their own cost. The following clause shall be included in all the contracts to be executed for (i) procurement of goods and services and (b) works related contract involving supply of goods and services by contractor: "Tax invoice (s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act,2017."
- 10) **Bids shall remain valid** for a period not less than **120 days** (One Hundred Twenty) from the last date of submission of Financial Bid / Sealed Bid. If the bidder withdraws the bid during the period of bid validity the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.
- 11) **CONDITIONAL and INCOMPLETE TENDER** will not be accepted under any circumstances.
- 12) The **Superintending Engineer, North Circle, GAP Wing, Water & Sanitation Sector, KMDA** reserves the right to cancel the N.I.Q. due to unavoidable circumstances and no claim in this respect will be entertained.
- 13) During scrutiny, if it is come to the notice to quotation inviting authority that the credential or any other papers found incorrect/manufactured/fabricated, that quotationer will not be allowed to participate in the quotation and that application will be out rightly rejected without any prejudice with forfeiture of earnest money forthwith.

List of "Technically Qualified Bidders" will be published in the web portal only. Financial Bid will be opened within a short period after such publication. Therefore Bidders are requested to view the tender status on a regular basis. In case if there be any objection regarding Pre-qualification/ list of " Technically Qualified Bidders", that objection should be lodged to the Chairman, Quotation/Bid Evaluation Committee within **24 hours** from the date and time of publication of list of qualified Agency and beyond that time schedule no objection will be entertained by the Quotation/Bid Evaluation Committee.

- 14) Before issuance of the LOI, the tender inviting authority may verify the credential & other documents of the lowest quotationer if found necessary. After verification, if it is found that such documents submitted by the lowest quotationer is either manufacture or false in that case, LOI will not be issued in favour of the quotationer under any circumstances. In that case Bidder's Earnest Money/ Bid Security shall be forfeited.
- 15) **Language of Tender:-** The tender shall be submitted in the prescribed form in English. All literatures and correspondence in connection with the quotations shall be in English.
- 16) **Others:-** The Quotation Notice along with other documents like **Tender Form No. - 1 KMDA, Technical Specification, Special Terms and Conditions, General Terms and Conditions, BOQ, Addendums and corrigendum's etc.** whatever documents uploaded by the department concerned thereto shall be part and parcel of the Quotation. The agency must go through carefully the Special Terms and Conditions uploaded by the department before quoting his rate. **All the bidders are requested to upload only necessary documents for the quotation.**

Uploading unnecessary / irrelevant documents may create problem in the evaluation process. In that case any inadvertent mistake during evaluation of the tender, Quotation Inviting Authority (QIA) will not be responsible.

17) Provision of Defect Liability Period & Refund of Security Deposit :

Prospective bidders shall have to execute the work in such a manner so that appropriate service level for the stipulated work is to be maintained during stipulated contractual period till completion and a Defect Liability Period is 1 (One) year. If any defect / damage is found during the period as mentioned above, the contractor shall make good the same at his own expense to the specification at par with instant project work, or in default, the Engineer-in-charge may cause the same to be made good by other agency and deduct the expense (for which the certificate of the Engineer-in-charge shall be final) from any sums that may be then, or at any time thereafter become due to contractor, or from his security deposit, or the proceeds of the sale thereof, or of sufficient portion thereof or from any pending dues for any contract with KMDA . Refund of Security Deposit will only be made after completion of Defect Liability Period (DLP).

18) Additional Performance Security:-

The authenticated estimated amount Rs.76,08,462.00 (**Rupees Seventy-Six Lakh Eight Thousand Four Hundred Sixty-Two Only**) for Protection work of the embankment of 10 MLD WSP Sewage Treatment Plant (STP) located at Madrail under Bhatpara Municipal Area. put to tender is reserved with the Tender Inviting Authority (TIA). The Additional Performance Security @10% of the tendered amount shall be obtained from successful bidder, if the accepted bid value is 80% or less of the estimated work value which is reserved with TIA, Additional Performance Security shall be equal to 10% of the tendered amount and be submitted in the form of Bank Guarantee from any Scheduled Bank before issuance of the Work Order. If the bidder fails to submit the Additional Performance Security within seven working days from the date of issuance of Letter of Acceptance, his earnest money will be forfeited and other necessary action as per NIT like Blacklisting of the contractor, etc. may be taken. The said Bank Guarantee shall have to be valid upto the end of the Successful completion of the work and shall be renewed accordingly, if required. If the bidder fails to complete the work successfully, the Additional Performance Security shall be forfeited at any time during the pendency of the Contract period after serving proper notice to the contractor.

19) Suspension and Debarment:-

Procedure for Suspension and Debarment of Contractors/bidder / Agency/Consultants will be as per order no(PWD, Govt. of WB) 547-W(C)/1M-387/15,dated16.11.2015 and 724-W(C)/1M-953/19,dated 19.12.2013. Technical Bid shall be treated as nonresponsive if anything adverse has come to the notice of the tender inviting authority against the Firm/Agency/ bidder so far as his performance within the jurisdiction of the concerned circle. The prospective bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility.

20) Language of Tender:- The tender shall be submitted in the prescribed form in English. All literatures and correspondence in connection with the tenders shall be in English.

21) Validity of Tender: Tender once submitted shall remain valid for a period **120 (one hundred twenty) days** from the date of receiving tender. Any extension of such validity period will be subjected to the concurrence of the tenderer.

22) Price Adjustment, Escalation, Mobilization Advance & Secured Advance and Price Preference:-

Price Adjustment (Increase or decrease of price) over any kind of materials, labour, fuel & lubricants etc will not be applicable for the work/works of this NIT. Similarly, Escalation over any kind of materials, labour, fuel & lubricants etc and Mobilization Advance will not be applicable for the work/works.

23) Others: - The Tender Notice along with other documents like **Tender Form No. - 1 KMDA, Technical Specification, Special Terms and Conditions , BOQ, Addendums and corrigendum's etc.** whatever documents uploaded by the department concerned thereto shall be part and parcel of the Tender. The agency must go through carefully the Special Terms and Conditions uploaded by the department before quoting his rate. **All the bidders are requested to upload only necessary documents for the tender. Uploading unnecessary/irrelevant documents may create problem in the evaluation process. In that case any inadvertent mistake during evaluation of the tender, Tender Inviting Authority (TIA) will not be responsible.**

24) Penalty for suppression / distortion of facts: If any document/statement/information submitted by any bidder in the tender is found to be false, the Tender Inviting Authority (TIA) will take legal action against the bidder including forfeiture of Earnest Money Deposit (EMD).”

25) Blacklisting: The bidder should not be blacklisted or debarred in last 5 years from any Central or State Government/Semi-government / PSUs / PHED / Water Boards / Water Utility departments. Such Debarment/Blacklisting shall be considered as disqualification towards eligibility unless the same has been revoked.

26) Insolvency / Bankruptcy Code: The applicant should not be currently under any Insolvency Bankruptcy Code (IBC) resolution process at National Company Law Tribunal (NCTL).

The tender inviting authority (TIA) reserves the right to accept or reject any or all the tenders without assigning any reason what so ever.

While evaluation, the committee may summon of the tenderers & seek clarification/ information or additional documents or original in hard copy/soft copy, if any shortfall documents may require by the TIA it shall only be uploaded in Tender portal (www.wbtenders.gov.in) within the stipulated time period.

Any of the documents already submitted & if they are not produced within the stipulated time frame, their bid will liable for rejection.


27) The Electrical Contractor & Supervisory License in relevant category must be submitted by the selected bidder before issuance of Work Order.

28) List of “Technically Qualified Bidders” will be published in the web portal only. The Financial Bid of the prospective Tenderers will be opened only if the tenderer qualifies in the Technica Bid. In case if there be any objection regarding Pre-qualification/ list of “Technically Qualified Bidders”, that objection should be lodged to the Tender Inviting Authority within **48 hours** from the date and time of publication of list of qualified Agency and beyond that time schedule no objection will be entertained by the Tender Inviting Authority. The decision of the Tender Inviting Authority will be final and binding to all concerned and no challenge against such decision will be entertained.

29) There shall be no provision of Arbitration. All the disputes arising from the provisions of the said agreement come under the jurisdiction of Calcutta High Court or any other competent court as the case may be.

30) If the L1 bidder does not agree to execute the job after opening of Bid, the Earnest Money will be forfeited without any further intimation and may be construed as an attempt to disturb the tendering process and dealt with accordingly legally including debarment up to 3(three) years of the Bidder.




