- (1) Qualification requirements as listed briefly below are required to be fulfilled by the prospective Tenderers / Bidders.
- (2) **Financial:**
 - A. The Bidder shall demonstrate that it possesses a net worth equivalent to minimum of INR 43.00 Lacs in any each of the last three financial years preceding the date of submission of bid.
 - B. The Bidder shall demonstrate by submitting along with its bid, a banker's certificate that it has available cash credit facility equivalent to minimum INR 34.48 Lacs as on the date of submission from any scheduled Bank or Public Finance Institute (PFI).
- (3) **Technical:**
 - A. The Bidder or its JV Member shall provide evidence that it has designed, developed, built, tested and commissioned FSTP /STP / CETP having a magnitude of for this contract during last 7 years preceding the month of publication of NIT meeting minimum BOD standard of 30mg/l as per following criteria:
 - a) For single completed work – FSTP - 17 KLD capacity (OR)
 - b) For 2 (Two) Nos. completed work - FSTP – 13 KLD capacity each (OR)

 - (2) A joint venture / Consortium of up to a maximum of 02 (Two) partners, if they meet the requirements of the Bidding Documents. For the purpose of assessing some qualification criteria, the qualifications and experience of Sub-Contractors may be included and the specific provisions in this regard as per RFP.
- (5) Scanned copy of original document of Valid PAN issued by the IT Department, Govt. of India, Latest Professional Tax Paid Challan as per Enrollment Rate Slab & P. TAX Enrollment Certificate, Valid Income Tax (For Last 5 Years), Valid 15 digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017,

Last 5 years Audited Balance Sheet, Employees Provident Fund Certificate & up-to-date Challan and ESI Registration Certificate & up-to-date Challan, Valid Trade License of the company must be submitted duly digitally signed at desired location in the website <https://wbtenders.gov.in>.

- (6) Scanned Copy of one affidavit before Notary will have to be submitted mentioning the correctness of the documents and a declaration of penalty debarment etc. faced by him under any Govt. / Semi-Govt. / Govt. Undertaking / Autonomous body (constituted under the State / Central statute) / Statutory Bodies and Local Bodies, submitted through online at desired location.
- (7) Proprietorship Firm / Partnership Firm / Consortium should submit necessary deed as per Annexure mentioned in the Bid Document at desired location through on line.

- (10) **Submission of Tender-** a) Pre-qualification/Technical Bid and Financial Bid both will have to be submitted online concurrently duly digitally signed in the website <https://wbtenders.gov.in> as per time schedule stated herein under. Time will be reckoned as per Server Clock. b) The Financial Bid of the prospective Tenderers / Bidders will be opened only if the tenderer qualifies in the Technical Bid. The decision of the Tender Inviting Authority will be final and binding to all concerned and no challenge against such decision will be entertained.
- (11) Tenders will be opened by the Superintending Engineer (GAP), GAP Wing, W & S Sector, KMDA or his authorized representative in presence of tenderer or their authorized representatives who may like to be present.
- (12) Bidding will be conducted through the National Competitive Bidding and is open to all eligible bidders.
- (13) A complete set of bidding documents will be available on the West Bengal Government website (<http://wbtenders.gov.in>). The bidders who are interested to participate in the bidding process can download the bid documents from the website.
- (14) Intending tenderer / bidder may download the tender documents from the website <https://wbtenders.gov.in> directly with the help of Digital Signature Certificate and scan copy of Bid Security to be uploaded in the form of Bank Guarantee issued from any Nationalized / Scheduled Bank or Public Finance Institute (PFI) or in the form of Insurance Surety Bond issued by an Insurance Company in favour of the Superintending Engineer, GAP, GAP Wing, Water & Sanitation Sector, KMDA payable at Kolkata.

The prospective Tenderer / Bidder shall have to submit scan copy of Bid Security through online, failing which the tender shall be rejected.

- (15) During scrutiny, if it comes to the notice of the Tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the Tender and that application will be rejected without any prejudice.

All the bidders are requested to upload only necessary documents for the tender.

- (16) Conditional / Incomplete Tender will not be accepted under any circumstances.

- (17) Bidder shall submit the hard copy of the original Bid Security and other required

documents[such as Power Attorney, Joint Bidding Agreement(if applicable), Certified copy of Net worth, bankers certificate of cash Credit, Credentials ..etc] to the Tender Inviting Authority. Failure to submit the hard copy within the time period prescribed in the bid document may be construed as an attempt to disturb the tendering process and dealt with accordingly as per tender conditions.

(19) **Site inspection before submission of tender**

Before submitting any tender, the intending tenderers should make themselves acquainted thoroughly with the local conditions prevailing at site by actual inspection of the site and taking into consideration all factors and difficulties like to be involved in the execution of work in all respect including transportation of materials, communication facilities, climate conditions, nature of soil, availability of local labour and market rate

prevailing in the locality etc. and no claim, whatsoever, will be entertained on these account afterwards. In this connection intending tenderers may contact the office of the Executive Engineer, concerned with the work between 11.30 hours to 16.30 hours on any working day prior to date of submission of tenders.

20.1 Opening of Technical Proposal

- a) Technical proposals will be opened by the Tender inviting authority or his authorized representative electronically from the website stated above, using their Digital Signature Certificate.
- b) Intending tenderers may remain present at the time of opening if they so desire.
- c) Decrypted (transformed into readable formats) documents of the Non-statutory Cover will be evaluated to finalize eligible tenderers.

20.2 Tender Evaluation Committee (TEC)

Committee already constituted for issuance of tender papers for high value tenders, vide CEO, KMDA's order will continue to function as Tender Evaluation Committee (TEC), for evaluation of Technical Proposals of the tenders, until further order.

20.3 Uploading so summary list of technically qualified renderers (1st round)

- i. Pursuant to scrutiny and decision of the Technical Evaluation Committee (TEC), the summary list of eligible tenderers for a particular serial of work whose Financial Proposals will be considered will be uploaded in the web portals.
- ii. While evaluation, the Committee may summon the tenderers and seek clarification / information or additional documents or original hard copy of any of the documents already submitted and if these cannot be produced within the stipulated timeframe, their proposals will be liable for rejection.

20.4 Opening and evaluation of Financial Proposal

- i. Financial proposals of the tenderers declared technically eligible by the Tender Evaluation Committee will be opened electronically by the Tender Inviting Authority from the web portal stated above on the prescribed date.
- ii. The encrypted copies will be decrypted and the rates will be read out to the contractors remaining present at that time.
- iii. After opening of the financial proposal the preliminary summary result containing inter-alia, name of contractors and the rates quoted by them

will be uploaded

- iv. If the Tender Accepting Authority is satisfied that the rate obtained is fair and reasonable and there is no scope of further lowering down of rate, he may after having the comparative statement checked, upload the final summary result containing the name of contractors and the rates quoted by them against each work after acceptance of the rate.
- v. The Tender Accepting Authority may ask any of the tenderers to submit analysis to justify the rate quoted by that tenderer.

(21) **Bid Validity:** The Bid will be valid for 180 days from the date of opening of the financial bid.
