



#### 6. Eligibility criteria for the bidders :-

##### A) Technical:-

i) Intending tenderers (firms/companies/individual contractors / joint venture / consortium) should have experience in the role of prime contractor (single entity or JV member) for Design, Construction, Testing & Commissioning of minimum **1 no. 0.9 MLD Capacity STP with associated infrastructure works including Pipe Network and successful Operation & Maintenance for at least 1½ continuous years in single project** in India during last 05(five) years from the date of issue of this tender notice;

OR

ii) Intending tenderers (firms/companies/individual contractors / joint venture / consortium) should have experience in the role of prime contractor (single entity or JV member) for Design, Construction, Testing & Commissioning of minimum **2 nos. 0.75 MLD Capacity STP with associated infrastructure works including Pipe Networks and successful Operation & Maintenance for at least 1 continuous year for each single project** in India during last 05(five) years from the date of issue of this tender notice;

In case of a running works (i.e. running O&M) the tenderer should have completed **1½ year's O&M** after construction of STP for being considered as eligible for bidding. In case of running works in any Govt./Semi-Govt. / Undertaking /Autonomous Bodies / Statutory Bodies and Local Bodies, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executing agency, i.e., the tenderer.  
[ Credential provided should be for completed and commissioned work]

##### B) Financial:-

Intending tenderers (firms / companies / individual contractors / joint venture / consortium) should produce minimum average annual turnover of **INR 17.6 Crore** for last 3 (Three) Financial Years.

[In case of joint venture / consortium, they should jointly meet at least 100% of the Qualifying amount asked for]

- a) Scanned copy of original documents i.e. Valid PAN issued by the IT Deptt., Govt. of India, Latest Professional Tax Paid Challan as per enrollment rate slab & P-TAX Enrollment Certificate, Valid Income Tax Returns (For Last 3 yrs), Valid 15 digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017, Last 3 yrs Audit balance sheet , Bank Solvency Certificate of minimum **Rs. 10.5 Crore** within 1 (one) year prior to the date of publishing of NIT ,Credentials (Work Order, & Completion Certificate of the same work as per SI-1 & 6,(A) of this NIT,Employees PF and ESI, Electrical Contractor & supervisory license in relevant category, Valid trade license of the company must be submitted duly digitally signed at desired location in the website <https://wbtenders.gov.in>.
- b) The following clause shall be included in all the contracts to be executed for (i) procurement of goods and services and (b) works related contract involving supply of goods and services by contractor: "Tax invoice (s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017."
- c) Scanned Copy of one affidavit before Notary will have to be submitted mentioning the correctness of the documents and a declaration of penalty debarment etc. faced by him under any Govt./Semi-Govt./Govt. Undertaking /Autonomous body (constituted under the State/Central statute)/ Statutory Bodies and Local Bodies, submitted through online at desired location (as per Annexure-I) and declaration by the tenderer as per prescribed format ( Annexure-I).
- d) Partnership / Joint Venture / Consortium Firm should submit necessary deed at desired location through on line.
- e) **Price Adjustment, Escalation, Mobilization Advance & Secured Advance and Price Preference:-**  
Price Adjustment (Increase or decrease of price) over any kind of materials, labour, fuel & lubricants etc will not be applicable for the work/works of this NIT. Similarly Escalation over any kind of materials, labour, fuel & lubricants etc and Mobilization Advance will not be applicable for the work/works.
- f) **Earnest Money:-**The initial Earnest Money shall be of **Rs.10,00,000 /-**( Rupees Ten Lakh Only), shall be deposited through online as per the system in the tender portal i.e. ([www.wbtenders.gov.in](http://www.wbtenders.gov.in)) in the respective field, failing which the tender shall be rejected. The successful tenderer shall have to submit balance amount against Earnest Money @ **2%** of the awarded tender value, if that exceeds already deposited EMD the balance amount will be deposited in the form of Bank Guarantee drawn in favour of "**Superintending Engineer, North Circle, GAP Wing, W & S Sector, KMDA**" payable at Kolkata within seven working days from the date of issuance of Letter of Acceptance. The said Bank Guarantee shall have to be valid upto the end of the Successful completion of the work and shall be renewed accordingly.
- g) **Security Deposit**  
Earnest Money @ **2%** of the quoted value put to tender would be converted to initial Security Deposit in case of the successful bidder. Balance Security Deposit amounting to @ **8%** of the

work value shall be deducted from each and every R/A Bill as per prevailing order (subject to implementation of latest Govt. Order in this respect). No interest will be paid on Security Deposit.

After completion of the operation and maintenance, the Security Deposit may be refunded to the Contractor.

- x. Employees PF and ESI.
- xi. Structure and organization & CV of proposed Technical Key Personnel
- xii. The bidder shall have to submit Valid Electrical Contractor License with valid Supervisor's Certificate of Competency (SCC) and Engagement Letter of the Supervisor. Bidder may also participate in tender with execution of MOU/ Agreement (duly Notarized) with Electrical Contractor having valid Electrical Contractor License along with authorized supervisor. In that case the bidder will have to upload MOU/ Agreement (duly Notarized), Supervisor's Certificate of Competency (SCC) and Engagement Letter of the Supervisor.
- xiii. The prospective bidders shall have to submit the List of Technical Personnel, Health & Safety Personnel employed under the organization in respect of Civil/ Electro-mechanical/ Health & Safety part as applicable in details with names, qualification, experience (Authenticated documents in respect of qualification shall be furnished for Technical Evaluation).
- xiv. Scan Copy of portal generated EMD
- xv. Bank Solvency Certificate of minimum Rs. 10.5 Crore within 1 (one) year prior to the date of publishing of NIT.

***All the joint venture / consortium partner shall have to submit all documents mentioned in Para above i-viii & ix-xv also.***

**b) List of documents shall have to upload by a Joint venture/Partnership Firm in addition to SI. No. 7.a)**

- i) The power of Attorney for the firm for signing the tender by a partner.
- ii) Partnership Deed.

**c) List of documents shall have to upload by a Joint Venture/ Partnership Firm in addition to Sl. No. 7.a)**

- i) Copy of MoA/MoU on a stamp paper of Rs.100.00 outlining the joint interest to work on the project and specifying the other terms of agreement.
- ii) Copy of "Letter of Intent" on a stamp paper of Rs.100.00 outlining the joint interest to work on the project and specifying the other terms of agreement.

**d) Joint Venture / Consortium :**

Particulars regarding Joint Ventures/Consortium.

- i. One of the partners of any Joint Venture/ Consortium has to be designated as Lead partner and the same will be mentioned in MOA/MOU.
- ii. The Lead partner must hold minimum 51% equity capital of the company to be formed between them during the tenure of contract implementation.
- iii. The Lead partner or any partner must meet minimum Technical qualification criteria (as in Serial no. 6) prior to the date of issue of this tender in a single contract under any Govt./ Semi-Govt. organization/ Autonomous body (constituted under the State/ Central Statute) as principal employer within last 5 (five) years.
- iv. However, the Lead partner along with other partner/ partners should jointly meet at least 100% of the qualifying criteria asked for.
- v. The Lead partner shall have to apply for tender on behalf of Joint Ventures/ Consortium along with MoA/MoU.
- vi. In case of any litigation or in the event of any default arises during the execution/contract period of the agreement, the lead partner and JV partner/s will remain fully responsible.
- vii. Maximum number of JV / Consortium Members/partners allowed is 03 (Three) including the Lead Partner.
- viii. In case of Joint Ventures/Consortium firm, successful bidder will have to submit valid GST Registration, PAN Card, Trade License of the JV/Consortium Firm immediately after issuance of Letter of Intent (LOI) and before raising 1st R/A bill.
- ix. In case of Joint Venture, the earnest money and/or security deposit including earnest money shall be in the name of the Joint Venture that submits the Bid.

8. **Time of completion:** Time of completion shall be 24 (Twenty-Four) Months followed by 03 (Three) months Trial Run and **5 (Five) years O&M. O&M** shall be reckoned from the date of completion of the successful Trial Run of the project.

9. **Provision of Defect Liability Period & Refund of Security Deposit :**

Prospective bidders shall have to execute the work in such a manner so that appropriate service level for the stipulated work is to be maintained during stipulated contractual period till actual date of completion and a Defect Liability Period for the work is **05(Five) years from the date of actual successful Commissioning of the project i.e. till the end of Contract Period.** If any defect/ damage is found during the period as mentioned above, the contractor shall make good the same at his own expense to the specification at par with instant project work, or in default, the Engineer-in-charge may cause the same to be made good by other agency and deduct the expense (for which the certificate of the Engineer-in-charge shall be final) from any sums that may be then, or at any time thereafter become due to contractor, or from his security deposit, or the proceeds of the sale thereof, or of sufficient portion thereof or from any pending dues for any contract with KMDA. 30% of Security deposit shall be refunded to the contractor on expire of 4 (four) years

from the actual date of successful Commissioning of the project and the balance 70% security deposit shall be refunded to the contractor on expiry of 5(Five) years from the actual date of successful Commissioning of the project i.e. the end of Contract Period.

**10. Suspension and Debarment:-**

Procedure for Suspension and Debarment of Contractors/bidder / Agency/Consultants will be as per order no.(PWD, Govt. of WB) 547-W(C)/1M-387/15,dated 16.11.2015 and 724-W(C)/1M-953/19,dated 19.12.2013. Technical Bid shall be treated as nonresponsive if anything adverse has come to the notice of the tender inviting authority against the Firm/Agency/ bidder so far as his performance within the jurisdiction of the concerned circle. The prospective bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility.

**11. Language of Tender:-** The tender shall be submitted in the prescribed form in English. All literatures and correspondence in connection with the tenders shall be in English.

**12. Validity of Tender:** Tender once submitted shall remain valid for a period **120 (one hundred twenty) days** from the date of receiving tender. Any extension of such validity period will be subjected to the concurrence of the tenderer.

**13. Others:** - The Tender Notice along with other documents like **Tender Form No. - 1 KMDA, Technical Specification, Special Terms and Conditions , BOQ, Addendums and corrigendum's etc.** whatever documents uploaded by the department concerned thereto shall be part and parcel of the Tender. The agency must go through carefully the Special Terms and Conditions uploaded by the department before quoting his rate. **All the bidders are requested to upload only necessary documents for the tender. Uploading unnecessary/irrelevant documents may create problem in the evaluation process. In that case any inadvertent mistake during evaluation of the tender, Tender Inviting Authority (TIA) will not be responsible.**

**14. Penalty for suppression / distortion of facts:** If any document/statement/information submitted by any bidder in the tender is found to be false, the Tender Inviting Authority (TIA) will take legal action against the bidder including forfeiture of Earnest Money Deposit (EMD)."

**15. Blacklisting / Poor Performance / Termination :** The bidder should not be blacklisted or debarred in last 5 years from any Central or State Government/Semi-government / PSUs / PHED / Water Boards / Water Utility departments. The bidder should not have poor performance record or should not have been terminated for their default in the last 5 years from any Central or State Government/Semi-government / PSUs / PHED / Water Boards / Water Utility departments. Such suspension / debarment / termination, unless the same has been revoked, will be considered as disqualification towards eligibility.

**16. Insolvency / Bankruptcy Code:** The applicant should not be currently under any Insolvency Bankruptcy Code (IBC) resolution process at National Company Law Tribunal (NCTL).

**17.** The tender inviting authority (TIA) reserves the right to accept or reject any or all the tenders without assigning any reason what so ever. The TIA reserves the right to waive minor deviations in the qualification criteria if they do not materially affect the capabilities of a bidder to perform the Contract.

**18. While evaluation, the committee may summon of the tenderers & seek clarification/**

**information or additional documents or original in hard copy/soft copy, if any shortfall documents may require by the TIA it shall only be uploaded in Tender portal ([www.wbtenders.gov.in](http://www.wbtenders.gov.in)) within the stipulated time period.**

19. **Any of the documents already submitted & if they are not produced within the stipulated time frame, their bid will liable for rejection.**

20. The bidder shall have to submit Valid Electrical Contractor License with valid Supervisor's Certificate of Competency (SCC) and Engagement Letter of the Supervisor. Bidder may also participate in tender with execution of MOU/ Agreement (duly Notarized) with Electrical Contractor having valid Electrical Contractor License along with authorized supervisor. In that case the bidder will have to upload MOU/ Agreement (duly Notarized), Supervisor's Certificate of Competency (SCC) and Engagement Letter of the Supervisor

21. List of "Technically Qualified Bidders" will be published in the web portal only. The Financial Bid of the prospective Tenderers will be opened only if the tenderer qualifies in the Technical Bid. In case if there be any objection regarding Pre-qualification/ list of "Technically Qualified Bidders", that objection should be lodged to the Tender Inviting Authority within **48 hours** from the date and time of publication of list of qualified Agency and beyond that time schedule objection will be entertained by the Tender Inviting Authority. The decision of the Tender Inviting Authority will be final and binding to all concerned and no challenge against such decision will be entertained.

**22. There shall be no provision of Arbitration. All the disputes arising from the provisions of the said agreement come under the jurisdiction of Calcutta High Court or any other competent court as the case may be.**

23. If the L1 bidder does not agree to execute the job after opening of Bid, the Earnest Money will be forfeited without any further intimation and may be construed as an attempt to disturb the tendering process and dealt with accordingly legally including debarment up to 3(three) years of the Bidder.

**24. Suspension and Debarment of Bidders, Contractors and Consultants during competitive bidding and contract implementation:**

The procedure as laid down below shall govern the suspension/debarment of Bidders/Contractors/Consultants (Contractors for brevity) involved in Government procurement for offences or violations committed during competitive bidding and contract implementation, for the works under different Departments of Government of West Bengal: - Grounds for Suspension and Debarment: -

(1) Submission of eligibility requirements containing false information or falsified documents.  
(2) Submission of Bids that contain false information or falsified documents, or the concealment of such information in the Bids in order to influence the outcome of eligibility screening or any other stage of the bidding process.

(3) Unauthorized use of one's name/digital signature certificate for the purpose of bidding process.

(4) Any documented unsolicited attempt by a bidder (A Person/Contractor/Agency /Joint Venture/Consortium/Corporation participating in the procurement process and/or a person / Contractor / Agency / Joint Venture / Consortium / Corporation having an agreement/contract for any procurement with the department shall be referred as Bidder) unduly influencing the outcome of the bidding in his favour.

(5) Refusal or failure to post a self-declaration to the effect of any previous debarment imposed by any other department of State Government and/or Central Government. (6) All other acts that tend to defeat the purpose of the competitive bidding such as lodging false complain about any Bidder, lodging false complain about any Officer duly authorized by the Department, restraining any interested bidder to participate in the bidding process, etc.

(7) Assignment and subcontracting of the contract or any part thereof without prior written

approval of the procuring entity.

(8) Whenever adverse reports related to adverse performance, misbehavior, direct or indirect involvement in threatening, making false complaints etc. damaging the reputation of the department or any other type complaint considered fit by the competent authority of the department, are received from more than one Officer or on more than one occasion from individual Officer.

(9) Refusal or failure to post the required performance security / earnest money within the prescribed time without justifiable cause. (10) Refusal to accept an award after issuance of "Letter of Acceptance" or enter into contract with the Government without justifiable cause.

(11) Failure of the Contractor, due solely to his fault or negligence, to mobilize and start work or performance within the specified period as mentioned in the "Letter of Acceptance", "Letter of Acceptance cum Work Order", "Work Order", "Notice to Proceed", "Award of Contract", etc.

(12) Failure by the Contractor to fully and faithfully comply with its contractual obligations without valid cause, or failure by the Contractor to comply with any written lawful instruction of the Procuring Entity/Authority (the Officer authorized by the KMDA for procurement and execution) or its representative(s) pursuant to the implementation of the Contract.

(13) For the procurement of Consultancy Service/Contracts, poor performance by the Consultant of his services arising from his fault or negligence. Any of the following acts by the Consultant shall be construed as poor performance. (i) Non-deployment of competent technical personnel, competent Engineers and/or work supervisors; (ii) Non-deployment of committed equipment, facilities, support staff and manpower; (iii) Defective design resulting in substantial corrective works in design and/or construction; (iv) Failure to deliver critical outputs due to consultant's fault or negligence; (v) Specifying materials which are inappropriate and substandard or way above acceptable standards leading to high procurement cost; (vi) Allowing defective workmanship or works by the Contractor being supervised by the Consultant.

(14) For the procurement of goods, unsatisfactory progress in the delivery of the goods by the manufacturer, supplier, or distributor arising from his fault or negligence and/or unsatisfactory or inferior quality of goods, vis-à-vis as laid down in the contract.

(15) Willful or deliberate abandonment or non-performance of the project or Contract by the Contractor resulting in substantial breach thereof without lawful and/or just cause.

**CATEGORY OF OFFENCE: -**

(A) First degree of offence: 1 to 15 of the above Article to be considered as First degree of offence.

(B) Second degree of offence: Any one of the offences as mentioned under 'A' above, committed by a particular Bidder/Contractor/Supplier on more than one occasion, be considered as Second degree of offence.

**In addition to the penalty of suspension/debarment, the bid security / earnest money posted by the concerned Bidder or prospective Bidder shall also be forfeited.**

**PENALTY FOR OFFENCE:-**

(I) For committing First degree of offence: Disqualifying a Bidder from participating in any procurement process under the Administrative Department of Government of West Bengal up to 2 (two) years.

(II) (II) For committing Second degree of offence: Disqualifying a Bidder from participating in any procurement process under the Administrative Department of Government of West Bengal up to 3 (three) years.




