

Tenders will be opened by the **Superintending Engineer, North Circle, GAP Wing, W & S Sector, KMDA** or his authorized representative in presence of tenderer or their authorized representatives who may like to be present.

6. Eligibility criteria for the bidders :-

A) Technical:-

- i) Intending tenderers should have experience in the role of prime contractor in similar nature of completed work (i.e. **Sewerage Pipe Network- Gravity Mains**) of the minimum value of **Rs. 80.22 Lakhs** in single project in India during last 05(five) years from the date of issue of this tender notice;
Or
- ii) Intending tenderers should have experience in the role of prime contractor in 2 (TWO) similar nature of completed work (i.e. **Sewerage Pipe Network- Gravity Mains**), each of the work having minimum value of **Rs. 60.17 Lakhs** in India during last 05(five) years from the date of issue of this tender notice;
Or
- iii) Intending tenderers should produce credentials of One single running work of Similar nature (i.e. **Sewerage Pipe Network- Gravity Mains**) which has been completed to the extent of **80% or more and value of which is not less than desired value at (i) above ;**

In case of running works, only those tenderer /bidders **who will submit the current certificate of satisfactory running work from the concerned Executive Engineer**, or equivalent competent authority will be eligible for the quotation. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executing agency, i.e. the quotationers/bidders.

B) Financial:-

Intending tenderers (firms / companies / individual contractors) should produce minimum average annual turnover of **INR 60 Lakh** for last 3 (Three) Financial Years.

Scanned copy of original documents i.e. Valid PAN issued by the IT Deptt., Govt. of India, Latest Professional Tax Paid Challan as per enrollment rate slab & P-TAX Enrollment Certificate, Valid Income Tax Returns (For Last 3 yrs), Valid 15 digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017, Last 3 yrs Audit balance sheet , Bank Solvency Certificate of minimum **Rs. 40 Lakh** within 1 (one) year prior to the date of publishing of NIT ,Credentials (Work Order, & Completion Certificate of the same work as per SI-1 & 6,(A) of this NIT, Employees PF and ESI, Electrical Contractor & supervisory license in relevant category, Valid trade license of the company must be submitted duly digitally signed at desired location in the website <https://wbtenders.gov.in>.

a) The following clause shall be included in all the contracts to be executed for (i) procurement of goods and services and (b) works related contract involving supply of goods and services by contractor: "Tax invoice (s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017."

b) Scanned Copy of one affidavit before Notary will have to be submitted mentioning the correctness of the documents and a declaration of penalty debarment etc. faced by him under any Govt./Semi-Govt./Govt. Undertaking /Autonomous body (constituted under the State/Central statute)/ Statutory Bodies and Local Bodies, submitted through online at desired location (as per Annexure-I) and declaration by the tenderer as per prescribed format (Annexure-I).

c) **Price Adjustment, Escalation, Mobilization Advance & Secured Advance and Price Preference:-**

Price Adjustment (Increase or decrease of price) over any kind of materials, labour, fuel & lubricants etc will not be applicable for the work/works of this NIT. Similarly Escalation over any kind of materials, labour, fuel & lubricants etc and Mobilization Advance will not be applicable for the work/works.

Earnest Money:-The initial Earnest Money shall be of **Rs. 4,01,127/-** (Rupees Four Lakh One Thousand One Hundred Twenty-Seven Only) through online as per the System., shall be deposited through online as per the system in the tender portal i.e. (www.wbtenders.gov.in) in the respective field, failing which the tender shall be rejected. The successful tenderer shall have to submit balance amount against Earnest Money @ 2% of the awarded tender value, if that exceeds already deposited EMD. The balance amount will be deposited in the form of Demand Draft drawn in favour of "Kolkata Metropolitan Development Authority" of a scheduled Indian Bank at Kolkata, payable at Kolkata within fourteen working days from the date of issuance of Letter of Acceptance. Security Deposit

Earnest Money @ 2% of the quoted value put to tender would be converted to initial Security Deposit in case of the successful bidder. Balance Security Deposit amounting to @ 8% of the work value shall be deducted from each and every R/A Bill as per prevailing order (subject to implementation of latest Govt. Order in this respect). No interest will be paid on Security Deposit.

"While issuing Bank Guarantees in favor of KMDA, the issuing applicant must mention receiver's details as ICICI Bank, IFSC Code: ICIC0006950, Branch Salt Lake, Sector-1, West Bengal, in BG text at which SFMS IFIN760 message to be sent by the issuing bank to establish the authenticity of the given BG"

Refund of Security Deposit will only be made after completion of Defect Liability Period (DLP) in the following manner:

- i. 30% of the security deposit shall be refunded to the contractor on expiry of **two** years from the actual date of completion of the work;
- ii. The balance 70% of the security deposit shall be refunded to the contractor on expiry of **three** years from the actual date of completion of the work;

- xi. Structure and organization & CV of proposed Technical Key Personnel
- xii. The prospective bidders shall have to submit the List of Technical Personnel, Health & Safety Personnel employed under the organization in respect of Civil/ Electro-mechanical/ Health & Safety part as applicable in details with names, qualification, experience (Authenticated documents in respect of qualification shall be furnished for Technical Evaluation).
- xiii. Scan Copy of portal generated EMD
- xiv. Bank Solvency Certificate of minimum **Rs. 40 Lakh** within 1 (one) year prior to the date of publishing of NIT.

8. **Time of completion:** Time of completion shall be 12 (Twelve) Months followed by 1 month's Trial Run.

9. **Provision of Defect Liability Period & Refund of Security Deposit :**

Prospective bidders shall have to execute the work in such a manner so that appropriate service level for the stipulated work is to be maintained during stipulated contractual period till actual date of completion and a Defect Liability Period of **03(Three) Years from the date of actual completion of the project**. If any defect/ damage is found during the period as mentioned above, the contractor shall make good the same at his own expense to the specification at par with instant project work, or in default, the Engineer- in-charge may cause the same to be made good by other agency and deduct the expense (for which the certificate of the Engineer-in-charge shall be final) from any sums that may be then, or at any time thereafter become due to contractor, or from his security deposit, or the proceeds of the sale thereof, or of sufficient portion thereof or from any pending dues for any contract with KMDA..

10. **Additional Performance Security:-** The estimated amount put to tender is **Rs. 2,00,56,360.00**. The Additional Performance Security @10% of the tendered amount shall be obtained from successful bidder, if the accepted bid value is 80% or less of the estimate put to tender. Additional Performance Security shall be equal to 10% of the tendered amount and be submitted in the form of Bank Guarantee from any Scheduled Bank before issuance of the Work Order. If the bidder fails to submit the Additional Performance Security within **Seven** working days from the date of issuance of Letter of Acceptance, his earnest money will be forfeited and other necessary actions as per NIT like blacklisting of the contractor etc. may be taken. The said Bank Guarantee shall be valid up-to the end of the Contract period and shall be renewed accordingly, if required. The Bank Guarantee shall be returned immediately on successful completion of the Contract. If the bidder fails to complete the work successfully, the Additional Performance Security shall be forfeited at any time during the pendency of the Contract period after serving proper notice to the contractor.

11. **Suspension and Debarment:-**

Procedure for Suspension and Debarment of Contractors/bidder / Agency/Consultants will be as per order no.(PWD, Govt. of WB) 547-W(C) /1M-387/15,dated16.11.2015 and 724-W(C)/1M-953/19,dated 19.12.2013. Technical Bid shall be treated as nonresponsive if anything adverse has

come to the notice of the tender inviting authority against the Firm/Agency/ bidder so far as his performance within the jurisdiction of the concerned circle. The prospective bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility.

11. **Language of Tender:-** The tender shall be submitted in the prescribed form in English. All literatures and correspondence in connection with the tenders shall be in English.

12. **Validity of Tender:** Tender once submitted shall remain valid for a period **120 (one hundred twenty) days** from the date of receiving tender. Any extension of such validity period will be subjected to the concurrence of the tenderer.

13. **Others:** - The Tender Notice along with other documents like **Tender Form No. - 1 KMDA, Technical Specification, Special Terms and Conditions , BOQ, Addendums and corrigendum's etc.** whatever documents uploaded by the department concerned thereto shall be part and parcel of the Tender. The agency must go through carefully the Special Terms and Conditions uploaded by the department before quoting his rate. **All the bidders are requested to upload only necessary documents for the tender. Uploading unnecessary/irrelevant documents may create problem in the evaluation process. In that case any inadvertent mistake during evaluation of the tender, Tender Inviting Authority (TIA) will not be responsible.**

14. **Penalty for suppression / distortion of facts:** If any document/statement/information submitted by any bidder in the tender is found to be false, the Tender Inviting Authority (TIA) will take legal action against the bidder including forfeiture of Earnest Money Deposit (EMD)."

15. **Blacklisting / Poor Performance / Termination :** The bidder should not have been blacklisted or debarred during the five years preceding the date of issuance of the Notice Inviting Tender (NIT) by any Central or State Government/Semi-government / PSUs / PHED / Water Boards / Water Utility departments. Such suspension / debarment, unless the same has been revoked, will be considered as disqualification towards eligibility. The bidder should not have been terminated for their poor performance during the two years preceding the date of issuance of the NIT by any Central or State Government/Semi-government / PSUs / PHED / Water Boards / Water Utility departments. Such termination of the bidder will cause disqualification towards eligibility for this tender.

[An undertaking should be given stating thereby that the Firm has not been debarred or penalized for any reasons out of work by any Government Department, in Non – Judicial Stamp paper of appropriate value duly notarized as per Proforma given in Annexure_1, in absence of which the bid will be liable for rejection. [Non statutory Documents]

16. **Insolvency / Bankruptcy Code:** The applicant should not be currently under any Insolvency Bankruptcy Code (IBC) resolution process at National Company Law Tribunal (NCTL).

17. The tender inviting authority (TIA) reserves the right to accept or reject any or all the tenders without assigning any reason what so ever. The TIA reserves the right to waive minor deviations in the qualification criteria if they do not materially affect the capabilities of a bidder to perform the Contract.

18. **While evaluation, the committee may summon of the tenderers & seek clarification/information or additional documents or original in hard copy/soft copy, if any shortfall documents may require by the TIA it shall only be uploaded in Tender portal**

(www.wbtenders.gov.in) within the stipulated time period.

19. Any of the documents already submitted & if they are not produced within the stipulated time frame, their bid will liable for rejection.

20. List of "Technically Qualified Bidders" will be published in the web portal only. The Financial Bid of the prospective Tenderers will be opened only if the tenderer qualifies in the Technical Bid. In case if there be any objection regarding Pre-qualification/ list of "Technically Qualified Bidders", that objection should be lodged to the Tender Inviting Authority within **24 hours** from the date and time of publication of list of qualified Agency and beyond that time schedule objection will be entertained by the Tender Inviting Authority. The decision of the Tender Inviting Authority will be final and binding to all concerned and no challenge against such decision will be entertained.

21. **There shall be no provision of Arbitration. All the disputes arising from the provisions of the said agreement come under the jurisdiction of Calcutta High Court or any other competent court as the case may be.**

22. If the L1 bidder does not agree to execute the job after opening of Bid, the Earnest Money will be forfeited without any further intimation and may be construed as an attempt to disturb the tendering process and dealt with accordingly legally including debarment up to 3(three) years of the Bidder.

23. **Suspension and Debarment of Bidders, Contractors and Consultants during competitive bidding and contract implementation:**

The procedure as laid down below shall govern the suspension/debarment of Bidders/Contractors/Consultants (Contractors for brevity) involved in Government procurement for offences or violations committed during competitive bidding and contract implementation, for the works under different Departments of Government of West Bengal: -
Grounds for Suspension and Debarment: -

(1) Submission of eligibility requirements containing false information or falsified documents.
(2) Submission of Bids that contain false information or falsified documents, or the concealment of such information in the Bids in order to influence the outcome of eligibility screening or any other stage of the bidding process.

(3) Unauthorized use of one's name/digital signature certificate for the purpose of bidding process.

(4) Any documented unsolicited attempt by a bidder (A Person/Contractor/Agency /Joint Venture/Consortium/Corporation participating in the procurement process and/or a person / Contractor / Agency / Joint Venture / Consortium / Corporation having an agreement/contract for any procurement with the department shall be referred as Bidder) unduly influencing the outcome of the bidding in his favour.

(5) Refusal or failure to post a self-declaration to the effect of any previous debarment imposed by any other department of State Government and/or Central Government. (6) All other acts that tend to defeat the purpose of the competitive bidding such as lodging false complain about any Bidder, lodging false complain about any Officer duly authorized by the Department, restraining any interested bidder to participate in the bidding process, etc.

(7) Assignment and subcontracting of the contract or any part thereof without prior written approval of the procuring entity.

(8) Whenever adverse reports related to adverse performance, misbehavior, direct or indirect involvement in threatening, making false complaints etc. damaging the reputation of the department or any other type complaint considered fit by the competent authority of the department, are received from more than one Officer or on more than one occasion from individual Officer.

(9) Refusal or failure to post the required performance security / earnest money within the

prescribed time without justifiable cause. (10) Refusal to accept an award after issuance of "Letter of Acceptance" or enter into contract with the Government without justifiable cause.

(11) Failure of the Contractor, due solely to his fault or negligence, to mobilize and start work or performance within the specified period as mentioned in the "Letter of Acceptance", "Letter of Acceptance cum Work Order", "Work Order", "Notice to Proceed", "Award of Contract", etc.

(12) Failure by the Contractor to fully and faithfully comply with its contractual obligations without valid cause, or failure by the Contractor to comply with any written lawful instruction of the Procuring Entity/Authority (the Officer authorized by the KMDA for procurement and execution) or its representative(s) pursuant to the implementation of the Contract.

(13) For the procurement of Consultancy Service/Contracts, poor performance by the Consultant of his services arising from his fault or negligence. Any of the following acts by the Consultant shall be construed as poor performance. (i) Non-deployment of competent technical personnel, competent Engineers and/or work supervisors; (ii) Non-deployment of committed equipment, facilities, support staff and manpower; (iii) Defective design resulting in substantial corrective works in design and/or construction; (iv) Failure to deliver critical outputs due to consultant's fault or negligence; (v) Specifying materials which are inappropriate and substandard or way above acceptable standards leading to high procurement cost; (vi) Allowing defective workmanship or works by the Contractor being supervised by the Consultant.

(14) For the procurement of goods, unsatisfactory progress in the delivery of the goods by the manufacturer, supplier, or distributor arising from his fault or negligence and/or unsatisfactory or inferior quality of goods, vis-à-vis as laid down in the contract.

(15) Willful or deliberate abandonment or non-performance of the project or Contract by the Contractor resulting in substantial breach thereof without lawful and/or just cause.

CATEGORY OF OFFENCE: -

(A) First degree of offence: 1 to 15 of the above Article to be considered as First degree of offence.

(B) Second degree of offence: Any one of the offences as mentioned under 'A' above, committed by a particular Bidder/Contractor/Supplier on more than one occasion, be considered as Second degree of offence.

In addition to the penalty of suspension/debarment, the bid security / earnest money posted by the concerned Bidder or prospective Bidder shall also be forfeited.

PENALTY FOR OFFENCE:-

(I) For committing First degree of offence: Disqualifying a Bidder from participating in any procurement process under the Administrative Department of Government of West Bengal up to 2 (two) years.

(II) For committing Second degree of offence: Disqualifying a Bidder from participating in any procurement process under the Administrative Department of Government of West Bengal up to 3 (three) years.




