- 11. Instruction to the bidders.
- a. General guidance for e quotationing.
 Instructions/ Guidelines for quotations for electronic submission of the quotations have been annexed for assisting the Consultants to participate in e-quotationing.
- b. Registration of Consultants. Any Consultant willing to take part in the process of e-quotationing will have to be enrolled and registered with the Govt. e-Procurement system, through login onto https://wbtenders.gov.in the Consultant is to click on the link (Error! Hyperlink reference not valid.) for e-tendering site.

c. Digital Signature Certificate (DSC)

Each Consultant is required to obtain Digital Signature Certificate (DSC) for submission of quotations, from the approved service provider of the Controller of Certifying Authority, Govt. of India. (http://cca.gov.in) on payment of requisite amount. The Consultant can search the quotation and download NIQ and other quotation documents website onto logs he/she once electronically from computer https://wbtenders.gov.in. This is the only mood of collection of the quotation documents. A prospective Bidder shall be allowed to participate in the job either in the capacity of the individual or as a partner of a firm. If found to have applied several in single job all his applications will be rejected for that job. The Consultant can search & download NIQ & Quotation documents electronically from computer once he /she logs to the website mentioned Clause 1 using the Digital Signature Certificate. This is the only mode of collection of the Quotation Documents.

d. Submission of Quotations:

Quotations are to be submitted through online to the website stated in two folders at a time for each work; one is technical Bid and another financial bid before the prescribed date and time using the Digital Signature Certificate.

Technical Bid: Technical bid contain scanned copies of the following further in two folder.

NOTE: Failure of submission of any of the above mentioned documents (as stated SI-5) will render the quotation liable to summarily rejected for both statutory and non-statutory cover.

e. Financial Bid

- i) The financial Bid should contain the following documents in one folder i.e. Bill of Quantities (BOQ). Rate to be quoted including GST and any other Govt. statutory taxes as applicable.
- ii) Only Downloaded copies of the above documents are to be uploaded, virus scanned & digitally signed by the Consultant.

f. Opening & Evaluation of Quotation

Technical Bid will be opened by the Superintending Engineer, South Circle, GAP Wing, Water & Sanitation Sector, KMDA intending quotationer may remain present if they so desire Statutory Cover would be opened first & if found in order and correct. Non Statutory Cover will be opened. If there is any deficiency in the Statutory & Non Statutory documents the quotation will be summarily rejected.

- Decrypted (transformed in to a readable formats) documents of the non-statutory folder will be downloaded & handed over to the evaluation committee.
- iii) List technically qualified quotationers would be uploaded.
- NB: While evaluation, the Committee may summon of the quotations & seek clarification / information or additional documents or original hard copy of any of the documents already submitted & if they are not produced within the stipulated time frame, their bid will liable for rejection.

g) Opening and evaluation of Financial bid:

Financial bid of Quotationers declared technically eligible by the Quotation Evaluation Committee will be opened electronically from the web portal on the prescribed date and time. All agencies must have their existing/open a local office situated at Kolkata or its suburbs. Details of address and contact person of existing local office are required to be mentioned.

12. Qualification criteria:

The quotation inviting and Accepting Authority through a "Quotation Evaluation Committee" will determine the eligibility of each bidder. The bidders shall have to meet all the minimum criteria regarding:

- (1) Financial Capacity
- (2) Technical Capability comprising of personnel & equipment capability

(3) Experience / Credential

The eligibility of a bidder will be ascertained on the basis of the document(s) in support of the minimum criteria as mentioned in Sl. No. (5) above and the debarment declaration through affidavit in non-judicial stamp paper duly notarized. If any document submitted by a bidder is either manufactured or false, in such cases the eligibility of the bidder / quotationer will be rejected at any stage without any prejudice

- 13. List of "Technically Qualified Bidders" will be published in the web portal only. The Financial Bid of the prospective Tenderers will be opened only if the tenderer qualifies in the Technical Bid. In case if there be any objection regarding Pre-qualification/ list of "Technically Qualified Bidders", that objection should belodged to the Tender Inviting Authority within 48 hours from the date and time of publication of list of qualified Agency and beyond that time schedule objection will be entertained by the Tender Inviting Authority. The decision of the Tender Inviting Authority will be final and binding to all concerned and no challenge against such decision will be entertained
- 14. If the L1 bidder does not agree to execute the job after opening of Bid, the Earnest Money

will be forfeited without any further intimation and may be construed as an attempt to disturb the tendering process and dealt with accordingly legally including debarment up to 3(three) years of the Bidder.

15. There shall be no provision of Arbitration. All the disputes arising from the provisions of the said agreement come under the jurisdiction of Calcutta High Court or any other competent

court as the case may be.

17.
