- A. The Bidder shall demonstrate that it possesses a net worth equivalent to minimum of INR 12.30 Crore in any each of the three financial years from last four years preceding the date of submission of bid.
- B. The Bidder shall demonstrate by submitting along with its bid, a banker's certificate that it has available cash credit facility equivalent to minimum INR 8.2 Crore as on the date of submission from any scheduled Bank or Public Finance Institute (PFI) and same has to be provided along with the technical bid.
- C.
