(1) Scope of Work:

The prospective Bidders are advised to refer to the bidding documents for complete details.

(2) Qualification requirements as listed briefly below are required to be fulfilled by the prospective Tenderers / Bidders.



(3) **Financial:**

- A. The Bidder shall demonstrate that it possesses a net worth equivalent to minimum of INR 78.70 Lakhs in any each of the three financial years from last four years preceding the date of submission of bid.
- B. The Bidder shall demonstrate by submitting along with its bid, a banker's certificate that it has available cash credit facility equivalent to minimum INR 62.95 Lakhs as on the date of submission from any scheduled Bank or Public Finance Institute (PFI) and same has to be provided along with the technical bid.
- C. The Bidder's audited balance sheets or, if not required by the laws of country, other financial statements acceptable to the owner, for the last five years shall be submitted and must demonstrate the current soundness of the Bidder's financial position and indicate its prospective long term profitability. If deemed necessary by the owner, the owner shall have the authority to make inquiries with the bidder/s bankers.

(4) **Technical:**

- A. The Bidder shall provide evidence that It has designed/developed/rejuvenated built, tested, and commissioned FSTP/STP/CETP having a magnitude for this contract during last 7 years preceding the month of publication of NIT as per following criteria:
  - a) For single completed FSTP work – 6.4 KLD capacity. OR
  - b) For 2 (Two) Nos. completed FSTP work – 4.8 KLD capacity each. OR
  - c) For 3 (Three) Nos. completed FSTP work –3.2 KLD capacity each. OR
  - d) For single completed new/upgraded, STP/CETP work – 3.5 MLD capacity
- B. The treatment technology proposed for FSTP in the contract by the bidder has been adopted (not necessarily build by the bidders) in at least one location during last 7 years preceding the month of publication of NIT and that FSTP has been operating successfully (meeting required performance standard of  $BOD \leq 30$  mg/l) for a period of 1 year during the last 7 years preceding the month of publication of NIT.
- C. The Bidder or his nominated sub-contractor has the experience in operating and maintaining successfully FSTP/STP/CETP of the minimum capacity as mentioned above clause 4(A) during 1 year over the last 7 years preceding the month on publication of NIT meeting the minimum BOD discharge standard of 30 mg/l.

- (15) During scrutiny, if it comes to the notice of the Tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the Tender and that application will be rejected without any prejudice.

All the bidders are requested to upload only necessary documents for the tender. Uploading unnecessary / irrelevant documents may create problem in the evaluation process. In that case any inadvertent mistake during evaluation of the tender, Tender Inviting Authority (TIA) will not be responsible.

- (16) List of “Technically Qualified Bidders” will be published in the web portal only. The Financial Bid of the prospective Tenderers will be opened only if the tenderer qualifies in the Technical Bid. In case if there be any objection regarding Pre-qualification/ list of “Technically Qualified Bidders”, that objection should be lodged to the Tender Inviting Authority within **48 hours (02 days)** from the date and time of publication of list of qualified Agency and beyond that time schedule no objection will be entertained by the Tender Inviting Authority. The decision of the Tender Inviting Authority will be final and binding to all concerned and no challenge against such decision will be entertained.
- (17) Conditional / Incomplete Tender will not be accepted under any circumstances.
