4. **Earnest Money deposit (EMD)** is to be remitted by the Tenderer in favour of **KMDA**. Payable at **KOLKATA**, as mentioned in the **column 4** above through Net- Banking/ RTGS/NEFT in respect of the Tender ID, as per requirement of e-Procurement System of Government of West Bengal (<https://wbtenders.gov.in/>).

In addition, instruction by the Finance Department **MEMORANDUM**, vide no. - **3975-F(Y)**; **Dated, 28th July, 2016** to be followed for ready reference and guidance.

5. The Total Earnest Money deposited will be converted to part initial security deposit and the balance amount as security deposit for this tender will be deducted **@ 8% (Eight percent)** of the gross bill value of each and every running bill and in the final bill an adjustment in percentage security deduction will be made so that the total security will be **@10 %** of the final gross bill value & it will be revised as per amendment published time to time by the Govt. & total deducted SD will be released after successful completion of DLP as mentioned in the memorandum of PWD Govt. of WB vide Memo:-5784-PW/L&A/2M-175/2017 Dt.12.09.2017.
6. Language of Quotation:- The tender shall be submitted in the prescribed form in English. All literatures and correspondence in connection with the tenders shall be in English.
7. Time of completion: Time of completion shall be **40 (Forty) days** and it will be reckoned from the date of issuance of work order.
8. **The tender inviting authority (TIA) reserves the right to accept or reject any or all the tenders without assigning any reason what so ever.**
9. While evaluation, the committee may summon of the tenderers & seek clarification/ information or additional documents or original in hard copy if any of the documents already submitted/seeking by TIA during Bid evaluation, if they are not produced within the stipulated time frame, their bid will liable for rejection.
10. Penalty for suppression / distortion of facts: If any document/statement/information submitted by any bidder in the tender is found to be false, the Tender Inviting Authority (TIA) will take legal action against the bidder including forfeiture of Earnest Money Deposit (EMD)."
11. If any discrepancy arises between two similar clauses on different notification the clause as stated in later notification will supersede former one.
12. All liabilities towards compensation of damages of Govt. properties and theft of Govt. material due to negligence of the personal engaged must be borne by the agency.
13. No extra cost towards any accident of the engaged personal will be borne by the department and any compensation towards any accident of the engaged personal will be borne by the agency.
14. The successful bidder will have to execute 5 (Five) sets of formal agreement with KMDA at the cost of Rs 300/- (Three hundred) per set as per norms of KMDA (in Cash).
15. Payment will depend on availability of fund and no claim whatsoever will be entertained for delay of issuance of work order as well as payment, if any. Intending bidders may consider this criterion while quoting their rates.
16. Declaration by the bidder in prescribed format as annex-I is to be uploaded.
17. Joint Ventures will not be allowed.
18. Engagement of Sub-Contractor/Subletting is not permitted.
19. All materials required for execution of the work (as per BOQ) shall be supplied by the contractor at their own cost.

20. Bid evaluation shall be done as per latest guideline of The Govt.
21. There shall be no provision of Arbitration.
22. No Adjustment of Price OR Price Escalation of any kind will be allowed.
23. No Price preference will be allowed for the Work under this NIT.
24. No mobilization advance and secured advance will be allowed
25. **The Superintending Engineer, HIT Wing, KMDA** reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained. At any stage of bidding or even after award of contract if any inadvertent typographical mistake is found in the BOQ or any other tender document, the same will be so corrected as to conform to the prevailing relevant Schedule of Rate and/ or Technically Sanctioned Estimate or any other document as the case may be.
26. All possible precautions should be taken for the safety of the people and work force deployed at worksite as per safety rule in force Contractor will remain responsible for his labour in respect of his liabilities under the Workmen's Compensation Act etc. He must deal with such cases as promptly as possible. Proper signs as per as per relevant category of work will have to be made by the contractor at his own costs.
27. The evaluation would be made by the TIA in accordance with latest Govt. rules and regulation.

29. The intending Bidder, at his own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information's that may be necessary for preparing the Bid and entering into a contract for the services as mentioned in the Notice Inviting Tender, before submitting offer with full satisfaction, the cost of visiting the site shall be at his own expense.

INSTRUCTION TO BIDDERS

Instruction / Guidelines for tenders for electronic submission of tenders online have been annexed for assisting the contractors to participate in e- tendering.

- 1. Registration of Contractor:** - Any contractor willing to take part in the process of e – Tendering will have to be enrolled & registered with the Government e – Procurement system through logging on to <https://wbttenders.gov.in>. The contractor is to click on the link for e – Tendering site as given on the web portal.
- 2. Digital Signature Certificate (DSC):-** Each contractor is required to obtain a class - II or class – III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the national Information's Centre (NIC) on payment of requisite amount details are available at the Web Site stated in Clause -1 of Guideline to Bidder. DSC is given as a USB e – Token.
- 3. Collection of Tender documents:** - The contractor can search & download NIT & Tender documents electronically from computer once he logs on to the website mentioned Clause 1 using the Digital Signature Certificate. This is the only mode of collection of Tender documents.
- 4. Submission of Tenders: -**
 - a) General process of submission:** - Tenders are to be submitted through online to the website stated in Cl.1 in two folders at a time for each work, one is Technical bid and other is Financial Bid before the prescribed date and time using the Digital Signature Certificates.
 - b) Technical Bid:** - Technical Bid contain scanned copies of the followings further in two covers (folder).

A-1. Statutory Cover Containing.

- i) Demand Draft/Pay Order towards earnest money (EMD) as prescribed in the NIT.
- ii) NIT (download & upload the same digitally signed).
- iii) Declaration as per prescribed format.

N.B: Bidder must download KMDA Tender Form No-1, General Terms and Condition, Special Terms & Conditions, Technical Specifications, all other addendum, Corrigendum etc. whatever documents uploaded by the department in the web under the NIT and must go through carefully before quoting his rate. If there is any deficiency in the Statutory & Non statutory documents the tender will summarily be rejected.
